the relief food supplies at the Iraqi port of Umm Qasr. The vessel sailed from Cochin on 16.9.90 carrying food shipment of 9475 tonnes and arrived at Khor Fakkan (Oman) on 22.9.90. After replenishment of fresh water and provision of additional life jackets, the vessel sailed from Khor Fakkan on 22.9.90 and reached the Iraqi port of Umm Qasr on 26.9.90. Certain difficulties were experienced in off-loading the food stuff mainly due to administrative bottlenecks such as non-availability of equipment and labour.

- (e) The ship succeeded in its mission of delivering food stuff to Indian nationals and the nationals of other Countries stranded in Iraq and Kuwait. The vessel sailed from UMM Qasr on 12.12.90 and reached Dubai on 14.12.90. The vessel has since resumed its commercial operations.
- (f) The estimated expenditure on the cost of food supplies and its transport is around Rs. 8 crores. The entire expenditure will be borne by the Ministry of External Affairs
