Processing of Bombay High Crude

2160. SHRI N K SANGHI: SHRI B V. NAIK.

Will the Minister of PETROLEUM be pleased to state

- (a) whether processing of the Bombay High crude has posed some technical problems which may call for an examination of the desirability of restructuring the oil industry particularly its processing mechanism,
- (b) if so, the nature of difficulties now being experienced and whether these are likely to affect production of crude from Bombay High; and
- (c) the steps proposed to deal with them?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM (SHRI ZIAUR RAHMAN ANSARI): (a) Bombay High Crude is at present being processed in Bharat Refineries. As Bharat Refineries was designed to process imported Middle East crudes, and Bombay High crude has se area characteristics different from thos the imported crudes, processing of this crude in this Refinery poses certain problems To overcome these problems the Refinery needs to make certain adjustments in operation, and also addition of certain facilities of comparatively minor nature mainly for receiving, storing and transporting High Pour Point crude, and similarly for handling High Pour Point residual products produced from this crude These modifications and changes are presently underway, and do not call for any restructuring of the oil industry.

(b) 5 companies are engaged both in refining and marketing, 2 in refining and one in marketing only. One refinery company, namely Bongaigaon Refit cry and Petro-chemicals Limited is in the construction stage and one marketing company, namely Bitumen Marketing Corporation Limited has yet to commence commercial operations.
