Bringing more couples under Family Planning methods in Gujarat

4336. SHRI R. P. GAEKWAD: Will AND Minister of HEALTH the FAMILY WELFARE be pleased to state:

(a) whether it is a fact that although the sterilisation cumulative rate for Gujarat is 71.6 per 1000 against the 48.8 for the entire country. 35.36 per cent of Gujarat's 5.68 million reproductive couples are non-users of contraceptive methods, against the national average of 25 per cent of such eligible couples;

(b) if so, whether Government propose to give directives to State Government to bring such couples under protection of family planning methods; and

(c) if so, the details thereof?

THE MINISTER OF STATE IN THE AND FA-MINISTRY OF HEALTH NIHAR MILY WELFARE (SHRI RANJAN LASKAR): (a) to (c). As per information available with the Government, up to the end of September, 1981 cumulative rate of sterilisation in Gujarat was 96.63 per thousand as against the national level of 49.64. Percentage of couples protected against birth in Gujarat was 34.1 as against the national level of 24.2 as per details given below:---

However, the Government of India has been advising the Government of Gujarat as well as other State/Union Territory Governments from time to time to accelerate the pace of family planning programme in the State/ Union Territory with specific attention to the areas lagging behind in the programme.

'B class to Chittaranjan Township

4337. DR. SARADISH ROY: Will the Minister of RAILWAYS be pleased to state:

(a) whether the staff of Chittaranjan Locomotives Works have represented for classification of Chittaranjan Township as 'B' class city due to high cost of living there;

(b) whether Civil Authority and Local Railway Authority have also recommended for such classification of the township; and

(c) if so, the present position of the issue and steps taken by the Railways in this regard?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND AND SOCIAL WEL-EDUCATION FARE AND IN THE DEPARTMENT AFFAIRS OF PARLIAMENTARY (SHRI MLLIKARJJUN): (a) Yes.

(b) The Ministry of Railways are not aware of any recommendation by the Civil Authorities in this regard. The C.L.W. Administration has however, recommended classification of Chittaranjan as 'B-2' class city.

(c) Classification of cities for the purpose of Compensatory (City) Allowance for all Central Government Employees including those of the Ministry of Railways is done by the Ministry of Finance, who have advised that Chittaranjan does not qualify for 'B-2' at present.
