- (ii) Rs. 110 lakhs: For Centrally sponsored Soil Conservation Schemes. State-wise allocations are being workeđ out.

- (b) The following schemes are tentatively proposed to be undertaken by the Punjab Government in 1961-62:
 - i) Survey and Land Use Planning in Siwaliks and adjoining tracts.
 - (ii) Reclamation of water-logged, saline and alkaline soil.
 - (iii) Soil Conservation in watersheds for flood control.
 - (iv) Soil Conservation and works in desert area.
 - (v) Soil Conservation in ravine lands.
 - (vi) Soil Conservation in waste lands.
 - (vii) Soil Conservation and Demonstration.
 - (viii) Treatment of chos in Hoshiarpur and Ambala Districts with the help of tree protection belts.
 - (ix) Training in Soil Conservation.
 - (x) Land use Soil Survey.
 - * (xi) Soil Conservation Demonstration (Dry farming) Centres on Agricultural lands.
 - (xii) Soil Conservation works-Contour bunding and dry farming on agricultural lands.
 - (xiii) Dry Farming.
 - (xiv) Reclamation of saline and alkaline soils.
 - (xv) Soil Conservation works the catchment areas of River Valley Projects.

The financial allocation for these schemes is being finalised.

The question of establishing more centres will be considered in the light of results obtained.

The Minister of Health (Shri Karmarkar): (a) The minimum allocation sought for by the Central Council of Health is Rs. 350:00 crores.

(b) and (c). The tentative provision mentioned in the draft outline for the III Five Year Plan for the purpose is Rs. 300.00 crores vide page 109 thereof. The final allocations for the Plan and for different programmes have not yet been decided.

Small-pox in the Country

- (a) whether Small-pox has turned into an epidemic in Maharashtra, Assam and Uttar Pradesh since the beginning of this year;
- (b) if so, how many lives has it claimed so far; and

The Minister of Health (Shri Karmarkar): (a) Small-pox took an epidemic turn in Buldhana district of Maharashtra during the first, second and last week of January, 1961 and in the Wardha district of Maharashtra in the last three weeks of February, 1961. In U.P. and Assam there have been some cases of small-pox, but not in an epidemic form.

(b) and (c). The information about the number of cases and deaths during January and February, 1961 is given below:—
