

The following alternatives have been recommended in the project report :

- (i) A purely Flood control project costing Rs. 25.2 crores and,
- (ii) A Multipurpose project for Flood Control and hydro-power costing Rs. 39.6 crores.

The report prepared by the Central Water and Power Commission has been referred to two Consultants of the Ministry of Irrigation and Power for their opinion on the project proposals framed by the Commission.

Copies of the project report have also been sent to the State Government for their consideration work on the Project can start only after the project is mooted by the State, approved by the Planning Commission and included in the Plan.

**NEW C.G.H.S. DISPENSARIES IN OLD DELHI AREAS**

2484. SHRI HARDAYAL DEVGUN : Will the Minister of HEALTH, FAMILY PLANNING AND URBAN DEVELOPMENT be pleased to state :

- (a) whether Government are considering any proposal to open new C.G.H.S. Dispensaries in the Old Delhi area as the Government employees residing in those areas are experiencing a lot of difficulty;
- (b) if so, when these will be opened and where, locality-wise; and
- (c) if not, the reasons therefor ?

**THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH, FAMILY PLANNING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY) :** (a) Yes.

(b) Subject to availability of funds and suitable accommodation for housing the dispensaries, it is proposed to open three new dispensaries in the Corporation area during 1968-69. The location will be decided when the budget position is clear.

(c) Does not arise.

**GOLD AND JEWELLERY WITH TEMPLES**

2485. SHRI BHOGENDRA JHA : Will the Minister of FINANCE be pleased to state :

- (a) whether Government have explored the possibility of putting the gold and jewellery in possession of temples into some productive purposes; and
- (b) if so, the steps taken in this direction?

**THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI DESAI) :** (a) No Sir. Government have no such proposal under consideration. Temples and public religious institutions have, however, in the past, on their own volition, invested some of their gold and jewellery in National Defence Gold Bonds and other schemes.
