4192. SHRI SAMAR GUHA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(c) whether Government's attention has been drawn to a report published in a Hindi periodical Biswa Neta, printed and published from Delhi, to the effect that Netaji Subhas Chandra Bose made a broadcast over Moscow Radio after the signing of the Tashkent Pact;

(b) whether the same periodical has published the photostatic copy of the reply by the Soviet Embassy, New Delhi concerning the matter; and

(c) if so, whether any enquiry into the published report will be made and if so, when?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI SURENDRA PAL SINGH): (a) and (b). Yes, Sir. The photostat copy of the letter from Radio Moscow mentions the name "Subhas Chandra" and not Subhas Chandra Bose".

(c) Our Embassy in Moscow has checked up with Moscow Radio authorities who have stated that the broadcast was made by an Indian student named Subhas Chandra.
