## COMMITTEE ON ABSENCE OF MEMBERS FROM THE SITTINGS OF THE HOUSE

## SECOND REPORT

## (SECOND LOK SABHA)

I, the Chairman of the Committee on Absence of Members from the Sittings of the House, having been authorised by the Committee, present this their Second Report.

- 2. The Committee held their sitting on the 27th August, 1957. The Committee considered twelve applications for leave of absence. The recommendations with respect to each application are given below:
- 2. Shri Balasaheb Salunka: The Member has requested for leave of absence for the entire period of the Second Session as he is suffering from Asthama. The total period of his absence during the current session would amount to 61 days. The Committee recommend that leave may be granted to the Member for 59 days in the first instance.
- 4. Shri Lachman Singh: The Member has applied for leave of absence from the 1st August, 1957 till the end of the current session as he has gone to participate in the 1857 centenary celebrations in the Andamans. The total period of his absence would amount to 44 days. The Committee recommend that leave may be granted to the Member for this period.

The Member attended the House on the 13th August, 1957. The total period of his absence amounts to 41 days. The Committee recommend that leave may be granted to the Member for this period.
- 7. Shri Joginder Sen-Mandi: The Member has requested for leave of absence from the 15th July to the 22nd August, 1957, as he was convalescing from an attack of typhoid fever. The Member attended the House for the first time on the 24th August, 1957 when he made an affirmation and took his seat in the House. The total period of his absence amounts to 40 days. The Committee recommend that leave for this period may be granted to the Member.
- 8. Shrimati Sucheta Kripalani: The Member has requested for leave of absence from the 4th August, to the 22nd August, 1957 as she was to go to Bangkok to attend a U.N. Seminar. The Member attended the House on the 26th August, 1957. The total period of her absence amounts to 20 days. The Committee recommend that leave for this period may be granted to the Member.
- 9. Shri S.C. Balakrishnan: The Member has requested for leave of absence for the period 15th July to the 4th August, 1957 as his brother-in-law was seriously ill. The total period of his absence amounts to 20 days. The Committee recommend that leave may be granted to the Member for this period.
