

Allotment of Galvanised Corrugated Sheets for Ceramic Unit at Kathua

*563. Shri Kashi Nath Pandey: Will the Minister of Steel, Mines and Metals be pleased to state:

(a) whether Government have received reports from Kashmir Government about the alleged misuse of steel galvanised corrugated sheets allotted to the Jammu and Kashmir Government for a ceramic unit at Kathua near Jammu; and

(b) if so, how much steel galvanised corrugated sheets have been sold in the black-market by the firm of Amin Chand Pyarelal?

The Minister of Steel, Mines and Metals (Dr. Chenna Reddy): (a) Yes, Sir.

(b) According to the State Government Report, against a total allotment of 106 tonnes 8 quintals and 40 Kgs. of Galvanised corrugated sheets only 29.2 tonnes has been accounted for. Apart from this, a small quantity (not specified) is lying at site. The reasons for variations between quantity allotted and quantity utilised could not be ascertained from the firm and as such the matter has been referred to C.B.I.
