try has conveyed its inability to share the expenses on writing off the loan as there is no scheme under this Ministry which could contribute towards this objective.

Relations with Israel

- SHRIMATI JAYAWANTI NAVIN 65 CHANDRA MEHTA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) the steps Government have taken to improve relations with Israel during the last 6 months?

THE MINISTER OF EXTERNAL AF-FAIRS (SHRI VIDYACHARAN SHUKLA): (a) At present India does not have any diplomatic relations with Israel. No steps have been taken to change this position. Government are of the view that the improvement of relations with Israel would be contingent upon genuine progress towards a Palestinian settlement.

Cotton Production

- 66. SHRI KADAMBUR M.R. JANARDHANAN: Will the Minister of AGRI-CULTURE be pleased to state:
- (a) the target of cotton production likely to be achieved during 1990-91; and
- (b) the cotton produced during the last year?

THE DEPUTY PRIME MINISTER AND MINISTER OF AGRICULTURE MINISTER OF TOURISM (SHRI DEVI LAL): (a) The final estimates of production of cotton for the year 1990-91 have not yet become due from the States. However, according to the present assessment, the production of cotton is expected to be around 106 lakh bales as against the target of 115 lakh bales.

(b) The cotton production during 1989-90 was 114.1 lakh bales.

THE DEPUTY MINISTER IN THE MIN-ISTRY OF PETROLEUM AND CHEMICALS AND DEPUTY MINISTER IN THE MINIS-TRY OF COMMUNICATIONS (SHRI JAI PARKASH): (a) Yes, Sir.

(b) During 1987-88, 1988-89 and 1989-90, 180 number of C-DOT exchanges were set up. 169 number of C-DOT exchanges have been commissioned upto November 1990 during the year 1990-91.

Cyclone Prone Areas in Andhra Pradesh

- 68. SHRIMATIT, MANEMMA: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether cyclone prone areas have been identified in Andhra Pradesh;
 - (b) if so, the details thereof; and
- (c) the precautionary measures taken in these areas to save the people from hardships caused by cyclones?

THE DEPUTY PRIME MINISTER AND MINISTER OF AGRICULTURE AND MINISTER OF TOURISM (SHRI DEVI LAL): (a) and (b). As per information received from the State Government of Andhra Pradesh, all the nine coastal districts are cyclone prone. These districts are Nellore, Prakasam Guntur, Krishna, East Godavari, West Godavari, Visakhapatnam, Vizianagaram, and Srikakulam. For the purpose of long-term cyclone preparedness and construction of cyclone shelters in the coastal areas, these districts have further been divided into areas falling 0-5 kms., 5-10 kms., 10-20 kms., from the coastal line.

(c) The precautionary measures include early warning system, shelter belt afterestation, cyclone shelters, cyclone contingency plans and cyclone stores.
