## Utilisation of Tourist Potentialities in Orissa

75. SHRI SIVAJI PATNAIK: Will the Minister of TOURISM be pleased to state:

(a) whether the Union Government are aware of the tremendous tourist potentialities of Orissa with its sea beaches, Chilka and Anshupa lakes, national parks, bird sanctuaries, luxurient forest, hill stations, water-falls, historical and archaeological states;

(b) if so, what steps the Union Government propose to take the exploit the underutilised potentialities to earn a good amount of foreign exchange; and

(c) whether appropriate schemes are proposed to be undertaken in order to develop these tourist spots in the state?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINHA): (a) Yes, Sir.

(b) and (c). Development of tourist potential is primarily the responsibility of the State Governments. Based on specific proposals from State Governments, Minister of Tourism extends financial assistance to States, dependent upon the merit of each case, availability of funds and inter-se-priority. Tourism potential in the country, including the state of Orissa, could be further exploited to earn foreign exchange. The Ministry have sanctioned financial assistance for 19 projects during the Seventh Plan and 11 schemes have been prioritised to extend financial assistance to Government of Orissa for 1990-91.

## Re-Constitution of Telecommunication Advisory Committees

76. SHRI MANDHATA SINGH: Will the Minister of COMMUNICATIONS be pleased to state: (a) whether the Telecommunication Advisory Committees at different levels are proposed to be re-constituted; and

(b) if so, by what time? .

THE DEPUTY MINISTER IN THE MIN-ISTRY OF PETROLEUM AND CHEMICALS AND DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI JAI PARKASH): (a) and (b). Yes Sir, the reconstitution of various Telecom/Telephone advisory Committees is under process and these are expected to be reconstituted shortly.

THE DEPUTY MINISTER IN THE MIN-ISTRY OF PETROLEUM AND CHEMICALS AND DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI JAI PARKASH): (a) No, Sir.

(b) Only Hassan is provided with S.T.D. facility so far.

(c) The remaining talukas are proposed to be provided with S.T.D. during the current Plan period.

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JYANTILAL VIRCHANDBHAI SHAH): (a) Sir, Secretary to Government of India, Department of Agricultural Research & Education functions as Director-General of Indian Council of Agricultural Research. Presently Secretary, Department of Agriculture & Cooperation is holding the additional charge of the Department of Agricultural Research & Education.

(b) Union Public Service Commission has been requested to make selection for the post of Secretary to the Government of India, Department of Agricultural Research & Education.

THE MINISTER OF WATER RE-SOURCES AND MINISTER OF SURFACE TRANSPORT (SHRI MANUBHAI KOTADIA): (a) and (b). Ground Water studies in drought prone areas of Bihar have already been completed. During 1990-91, Reappraisal Hydrogeological Survey in 3000 sq. km. area is in progress in Dumka District. Exploratory drilling for ground water is being carried out in drought prone Palamau and Godda Districts.

(c) and (d). The State Government plans and implements Water Resources projects for the development of available ground water resources.

## Central Institute of Fisheries Technology, Calicut

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JYANTILAL VIRCHANDBHAI SHAH): Sir, There is a proposal to close down the research centre of the Central Institute of Fisheries Technology located at Calicut, but an Extension Cell of the Institute will continue to function at Calicut.

(b) The Research Centre has outlived its utility.
