THE MINISTER OF WATER RE-SOURCES AND MINISTER OF SURFACE **TRANSPORT** (SHRI MANUBHAI KOTADIA): (a) and (b). According to the Rehabilitation and Resettlement Policy of Madhya Pradesh for oustees of Narmada (Indira Sagar) Project-Madhya Pradesh, the land owners and encroachers are to be allotted agricultural lands, free of cost abadi plots to all the oustees including major sons, grant-in-aid, free transportation of personal effects including salvaged dismantelled building materials, etc. rehabilitation grant, civil amenities, priority in employment on the project and allied works. The entire work concerning rehabilitation and resettlement of oustees is to be carried out in five phases so as to be synchronous with the progress on the dam work. Under Section 4 & 6 of Land Acquisition Act Notification for 8 villages and Harsud Town has been issued. An industrial Training Institute for training the landless laboures has been set up. Household survey for 110 villages out of 254 villages has been completed. Rehabilitation plans for 12 villages coming under Phase-I of submergence are under way. For Harsud town also action has been initiated for preparation of plans for a new township near Chandara village in Khandwa.
