- (a) whether the Pakistan Prime Minister has recently reiterated his Government's support to the secessionists in Jammu and Kashmir and also stated that Simla Agreement is not binding on Pakistan.

- (c) whether the Government propose to have fresh dialogue with the Pakistan Government to solve this critical issue; and

THE MINISTER OF EXTERNAL AF-FAIRS (SHRI VIDYACHARAN SHUKLA): (a) and (b). Government have seen the report in the Indian Express of 24.11.90 in which the Pakistan Prime Minister is reported to have said that Pakistan will continue to provide "moral, political and diplomatic support to Kashmiris.". He also reportedly stated the importance of resolving Indo-Pakistan issue "within or without the Simla Agreement" and that "nothing (including the Simla Agreement) is binding on us'. The Pakistan foreign Office in a statement issued on 25 November said that the remark of Pakistan PM has been "incorrectly quoted " and that Pakistan remains committed to all its bilateral and international commitments including the Simla Agreement.

(c) and (d). The foreign Secretaries of India and Pakistan held the Third round of Talks in Islamabad from December 18-20. It was pointed out that Pakistan's continued support to terrorism directed against India in Punjab and Jammu & Kashmir, was not only a violation of the Simla Agreement and of universally accepted norms of inter-State conduct, but also adversely affected the relationship between the two countries. It has been agreed that the foreign Secretaries will meet again towards the end of February 1991, to pursue these discussions further.
