during July-November, 1990. No proposal for operating the scheme during the next season has been received from the State Government.

## Lack of Planning in Procurement of Computer system

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI JAI PARKASH): (a) No, Sir.

- (c) The district headquarters of Ghazipur and jounpur are already connected to the state capital through Varanasi trunk automatic exchange.

It is proposed to provide telecom link by the provision of STD facility for all the subdivisional headqurters progressively during 8th plan period, with the future replacement of exchanges by electronic.

The follwoing sub-divisional headquarters of Jaunpur and Ghazipur district are

proposed for provision of STD facility during the 8th plan period:-

Muhammadabad. Saidpur, Zamania, Machlishabar, Meriahun, Keraket and Shahganj.

## **Road Accidents**

178. SHRI RAM SAGAR (Saidpur): SHRI JAG PAL SINGH:

- (a) the number of vehicles, categorywise involved in road accidents in Delhi During past six months and how does this compare with the preceding last three years and the number of peple killed in these accidents;

- (c) the main reasons for road accidents in Delhi;
- (d) whether the DTC has been back into its fleet the private buses that were involved in fatal accidents:
- (e) if so, the reasons therefor and how may of such buses have again been involved in accidents; and
  - (f) whether the Government proposes

to remvoe all such buses out of the fleet and if not, the reasons therefor?

THE MINISTER OF WATER RE-SOURCES AND MINISTER OF SURFACE TRANSPORT (SHRI MANUBHAI KOTADIA): (a) A statement is attached.

  - (c) (i) Drivers' negligence
    - (ii) Over-speeding
    - (iii) Boarding and alighting
    - (iv) Inadequate street lighting

- (e) In response to a directive issued by the Delhi High Court, the representations received from the private bus operators were examined by the Ministry of Surface Transport and a decision was taken to re-engage the buses which were involved in accidents. The reinductment is however subject to certain conditions such as blacklisting of drivers involved in fatal accidents, suspension of buses for varying periods etc. After re-engagement, none of the buses has been involved in fatal accidents again.
