Iraq's Offer of Oil

185. SHRISHANTARAM POTDUKHE: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Iraq has offered India worth 500 million of oil in full settlemet of dues accumulated over the past twelive years;
- (b) if so, whether the Government have considered this offer; and
 - (c) if not, the reasons thereor?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI VIDYACHARAN 'SHUKLA): (a) Yes, Sir.

(b) and (c). In view of the economic sanctions imposed on Iraq under the Security Council Resolution 661, it is not possible to import oil from Iraq.

Exchange Building at Kohima has been completed.

- (b) Guwahati and Silchar in Assam, Shillong in Meghalaya and Imphal in Manipur.
- (c) Kohima, Dimapur, Guwahati and Shilling will be inter-linked with each other from 1.1.91.
