The DTC have informed that nearly 159 applications of dependents of deceased employees for employment on compassionate grouds have been pending for over three years on account of non-availability of vacancies. All efforts are being made to provide regular appointment to the dependents of the deceased employees of DTC to the extent possible from time to time. Some are also emloyed on daily rates of pay, on seasonap basis, whenever there is a need for such engagement.
