long term training in gymnastics.

(b) 64 children were called for the Assessment Camp, of whom 33 were selected for long term training. The parents of the remaining 31 children have thereafter blocked the activities and the functioning of the gymnasium, insisting upon the inclusion of their children.

Since this is a Scheme geared towards promoting excellence among talented young sportspersons of potential, who would one day represent Indian at International levels, no compromise on the standards of selection can be permitted.

However, in order to satisfy the parents of these 31 children, a re-assessment by a foreign coach has been ordered.

- (c) No steps for improving the functioning of the gymnasium were required. However, the situation has been defused by action taken as mentioned in part (b) above and by visits of SAI officers, who have talked to the concerned parents and officials.
- (d) The proposed allocation for the year 1990-91 is Rs. 12 lakhs.

- (b) The Government with the help of the Rashtriya Veda Vidya Pratishthan an autonomous organisation under the Ministry, has organised:
  - Two Workshop and Round Table discussion respectively at Jaipur, Ahmedabad and Delhi.
  - A training camps for schools teachers from the southern states, at Tirupati,
  - A conference-cum-workshop at Bangalore in joint collaboration between Rashtriya Veda Vidya Pratishthan and Abhivan Vidya Bharati,
  - Assigned a fellowship to schools teacherforfurther research in Vedic Mathematics.
  - Commissioned a few scholars to write books on Vedic Mathematics; and
  - Included Lecturer in Vedic Mathematics in the NCERT's teachers

training programme and workshop on enrichment material.

- Further programme include, a regular programme of training for schools teachers in various parts of the country, a workshop on application of Vedic Mathematics on computers and financial support to various projects on Vedic Mathematics.
- (c) Yes, Sir, the Rashtriya Veda Vidya Pratishthan has reported that School of Economics Sciences and St. James School, London in the U.K. have shown interest in Vedic Mathematics, but no information is available on use of Vedic Mathematics in functioning of computers.
