methods are adjusted to the functioning level of the children in specific areas of disability. For blind children tactile and auditory training is provided whereas deaf children are provided with training in language and speech, Mentally retarded children are provided with more practice in the tasks to be learned. The evaluation procedures are also adjusted to the special needs of the the children.

UGC Grants to Himachal Pradesh University

4202. PROF. PREM KUMAR DHU-MAL: Will the PRIME MINISTER be pleased to state:

- (a) whether University Grants Commission has received any proposal from Himachal Pradesh University seeking grants to encourage sports;

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DE-VELOPMENT (SHRI CHIMANBHAI MEHTA): (a) to (c). Yes, Sir. According to the information furnished the University Grants Commission, the Commission received proposals from Himachal Pradesh University for assistance under the (NSO) National Sports Organisations programme. The Commission has agreed to provide assistance to the University according to availability of funds in a phased manner. It approved the construction of an outdoor stadium at a cost of Rs. 20.79 lakhs with the Commission's share limited to Rs. 7.50 lakhs. An amount of Rs. 6 lakhs has already been sanctioned in two instalments in August, 1969 and May, 1990 respectively. The balance would be sanctioned by the Commission depending upon the progress of work and on receipt of required documents from the University.

Starting of Vocational Studies Courses in Himachal Pradesh University

It is also pointed out in this article that there is uncertainty about the estimates relating to global sea level for the year 2050; these vary from 23.8 cms to 106.7 cms and for the year 2100 from 56.2 cms to 345.9 cms.
