## Investment in Central Public Sector Undertakings

4218. SHRI ABDUL SAMAD: Will the PRIME MINISTER be pleased to state

 (a) the total investment in central public sector undertakings as on 31 March 1990 industry-wise, State/Union Territory-wise;

(b) the total borrowings by them as on 31 March, 1990;

(c) the break-up thereof among public sector financial institutes, private banks and the public; and

(d) the total estimated profit before tax during 1989-90?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF PRO-GRAMME IMPLEMENTATION (SHRI BHAGEY GOBARDHAN): (a) to (c). The estimated total investment in Central Public sector enterprises as on 31.3.90 is Rs. 102, 600 crores. Details of investments and borrowings will become available only towards the end of the year when all the annual audited accounts of the enterprises ar received and compiled.

(d) The estimated total profit before tax during 1989-90 is Rs. 4930 crores. SC/ST/SGSSSK-SK

## Reservation for SCs/STs in Public Sector Undertakings

4219. SHRIJ. CHOKKA RAO: Will the PRIME MINISTER be pleased to state:

(a) the number of posts reserved for SC/STs in higher category in various Central Public Undertakings;

(b) the steps taken to full up the posts so far and reasons for not getting required personnel in various categories;

(c) whether Government are reviewing and identifying the various categories of post for which SC/ST candidates are not available; and

(d) the programmes take up for training the required personnel for filling up the reserved vacancies?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF PRO-GRAMME IMPLEMENTATION (SHRI BHAGEY GOBARDHAN): (a) As in Govt. reservation is provided to the extent of 15% and 7-1/2% to SC & ST respectively, for vacancies filled by direct recruitment on All India basis by open competition in Public Sector Undertakings. For posts filled other than by open competition, the prescribed percentage is 16.2/ 3% and 7-1/2%.

(b) to (d). Various steps have been taken to ensure proper representation to Scheduled Castes and Scheduled Tribes in public sector undertakings, from time to time. These include relaxations and concessions with regard to age limit, examination fees, reimbursement of travelling expenses for attending interviews, separate interviews for candidates belonging to SC/ST, inclusion of a member belonging to SC/ST in Departmental Promotion Committee etc. Dereservation in direct recruitment has been banned in public sector undertakings.

The shortfall, particularly in Group 'A' Group 'B' posts is mainly due to non-availability of suitable SC/ST candidates in technical discipilines. Most of the public undertakings being in the manufacturing/production sector, there is a preponderance of technical posts in Group 'A' & Group 'B' services of public enterprises.

in continuation to the Special Recruitment Drive initiated in 1989, the public sector enterprises have now launched a Special Recruitment Drive (1990). In all, 10,461 physical vacanice in various groups have been identified for for recruitment, during the current drive. An action plan has been drawn up to fill these vacancies by the end of the October, 1990.

As regards training, PSUs have been advised to organise pre-recruitment training to SC/ST candidates, special recruitment tests exclusively for SC/STs, scholarship schemes for SC/ST students studying in IITs, IIMs, Regional Engineering Colleges, etc.

Fencing of the Kempegowda Tower in 5:6 - 6 Bangalore

4220. SHRI H.C. SRIKANTAIAH: Will the PRIME MINISTER be pleased to state:

(a) whether Government are aware of the unauthorised fencing by Defence authorities of Kampegowda Tower on the hilllock of the Ulsoor lake and the century old Munishware temple in Bangalore City;

(b) whether the Bangalore City Corporation has also requested to remove the above fencing; and

(c) if so, the remedial steps taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. RAJA RAMANNA): (a) The Defence land alone has been fenced by the local Military authorities for security reasons.

(b) and (c). The Bangalore City Corporation had brought to the notice of the au-
