Activities of Anti-Social Elements in Deihi

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND MIN-ISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SUBODH KANT SAHAY): (a) and (b). During the last 3 months viz. November, 1990 to January, 1991 3 cases of theft of motor vehicles/scooters and one case of theft of stereo from a Maruti Car were reported. No arrests have been made so far. A number of persons were interrogated but their involvement could not be established.

(c) Division Officers, Beat Officers and patrolling staff have been directed to intensify patrolling in the area to check and curb activities of anti-social elements.
