THE DEPUTY MINISTER IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS AND IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI IQBAL SINGH): (a) A copy of the recommendations adopted at the Sixth All India Whips' Conference held at Simla in October, 1967 was placed on the Table of the House on 14th November, 1967 in reply to Unstarred Question No. 199.

(b) and (c). The recommendations are of such a nature as would require consideration and implementation by the Government and Presiding Officers of Legislatures both at the Centre end in the States. They were accordingly communicated to the State Governments and the Presiding Officers of Parliament and State Legislatures for implementation to the extent feasible in their sphere of functions connected with the working of Parliamentary machine. Up-to-date reports about their implementation are still awaited from them. The position will be reviewed at the next All India Whips'

Conference. In so far as the Central Government is concerned, some of the recommendations stand implemented and others are under active consideration.

THE MINISTER OF PARLIAMENT-ARY AFFAIRS AND SHIPPING AND TRANSPORT (SARI RAGHU RAM-AIAH): As the House is aware, in pursuance of the Resolution moved by Shri P. Venkatasubbaiah in the Lok Sabha, the Ministry of Home affairs have set up a high level committee to examine this problem. The report of that committee was laid on the Table of the House on 18.2.69. Subject to allotment of time by the Business Advisory Committee this report is likely to be discussed after the Demands are voted.

SHRI RAGHU RAMAIAH: Whatever recommendations are made regarding opposition whips as well as regional whips they are under very active consideration.

श्री बृज भूषण लाल : दो सालों के सन्दर जो दल-बदल या डिफेन्शनस लेंजि-स्लेचसं में हुए हैं उनसे प्रपनी नेशनल स्टेबि-लटी के लिये बड़ा भारी खतरा है। इस बात को महेनजर रखते हुए जो व्हिप्स की कांफ्रेंस हुई थी उसमें कांसेन्सस प्राप्त घोपी-नियन यह थी, कि इन डिफेन्शनस को कानून

SHRI RAGHU RAMAIAH: I think the Congress Party has suffered more on account of defections,

श्री **मौलहू प्रसाद** : बिहार में फायदा हो रहा है।

MR. SPEAKER: It is a two-way traffic now. Previously, it was only one way traffic.

SHRI SRADHAKAR SUPAKAR: There are two ambiguous sentences in this statement, Paragraph 9(b) says that young legislators should be encouraged to undertake study tours and paragraph 10(b) says that young legislators should be encouraged to serve on various committees. May I know the age limit below which Members are supposed to be chicken-hearted and need to be encouraged?

SHRI RAGHU RAMAIAH: I think, my hon. friend knows that better.

SHRI RANGA: May I know whether at the last meeting, if not at the earlier meeting, any consideration has been given to maintaining decorum, decency and order in the House and cooperating with the Speaker with the cooperation of the whip? I am all in favour of all the privileges being given to the whips but, at the same time, there should be certain duties also to be performed by whips as well as their leaders but most especially by whips because they are in charge of maintaining discipline among themselves.

Secondly, would any consideration be given also to the need for the whips not to-try to entice away Members of other parties and if they were to admit anyone at all belonging to some other party into their own party would they have adequate consultations with the leaders of the parties concerned and the whips concerned also?

SHRI RAGHU RAMAIAH: A number of suggestions have been made in regard to the first point raised by the hon. Member, Shri Ranga, I might be allowed to point out that the Conference, while emphasizing that the privilege of raising points of order should not in any way be curtailed, recommended that such a privilege should not be utilised meruly to catch the eye of the Speaker. This is one of the measures by which this Conference tries to regulate decorum in the House if I may say so. There are various other things. It is already laid on the Table on the House.

MR. SPEAKER: That is the most important recommendation.

SHRI RAGHU RAMAIAH: As regards taking away Members through the whips and all that, whether it its done through the whips or otherwise, defection is defection and we are all against it. I have already indicated that the matter will come up for consideration again.

How could he give you the figures when there were some changes only yesterday?

SHRI S. M. BANERJEE: I remember at this particular meeting, which was attended by me along with my hon. friend, Shri Kanwar Lal Gupta, and others, we had a discussion on defections and I said in that meeting itself that defection had a long history, Vibhisana was the first defector who defected from Ravana and joined Rama. That is there in the Ramayana. So, it is a very serious problem.

Apart from that, there were many recommendations, such as, that non-officials should be chairmen of the various committees in the States which are being presided over by district magistrates or officials. The entire committee, whether the Congress side or this side, was unanimous and Dr. Ram Subhag Singh, who presided over this conference, was also of the view that Members of Parliament or of State Legislatures should be given adequate representation and some respect and that they should not suffer at the hands of the district authorities who are always chairmen of those committees.

I would like to know whether this was forwarded to the State Governments and, if so, what is the reaction of the State Governments.

SHRI RAGHU RAMAIAH; This has been, along with other recommendations, forwarded to them. We have not yet got a complete reply from all the States.
