Barter Agreements

Will the Minister of Commerce and Industry be pleased to state:

(a) the total number of barter agreements entered into during the last three years;

(b) the goods exported under these agreements, with their values; and

(c) the basis for fixing the price of each commodity?

The Minister of International Trade in the Ministry of Commerce and Industry (Shri Manubhai Shah): (a) The total number of barter/link deals concluded during the last 3 years is 102.

(b) A large variety of goods, both traditional as well as non-traditional, have been exported to the value of Rs. 49:71 crores under these deals.

(c) The basis for fixing the prices is generally the ruling international price or prices. This differs with different commodities depending upon the circumstances prevailing at the time of the particular transaction.
