- (c) It is reported that 729 workers in the month of January and 229 in the month of February, 1963 were laid-off in mica mines in Bihar due to the shortage of detonators.
- (d) To meet the immediate requirements, 2.4 million detonators were airlifted during the first week of March. Simultaneously, steps were also taken to expedite the shipment of detonators, accordingly, 7.7 million ordinary detonators, 4.5 million electric detonators and 2.5 lakhs delay detonators were obtained on 21st March, 1963 and rushed to the mining areas.
- Shri P. R. Chakraverti: Have these supplies which were later on forth-coming fulfilled the demands of the mines in that area?

The Minister of Mines and Fuel (Shri K. D. Malaviya): Yes, Sir. Now there is no difficulty. The mica industry also informed me that they are satisfied. So is the coal industry.
