#### **Integrated Power Grid**

Will the Minister of Irrigation and **Power** be pleased to state:

(a) whether it is a fact that a special Committee set up by his Ministry some time back has recomended the division of the country into several Power grid in each zones, and to establish an integrated power grid in each zone; and (b) if so, whether this proposal has been accepted by Government and what are the main advantage of this scheme?

The Minister of State in the Ministry of Irrigation and Power (Shri Alagesan): (a) The Central Water & Power Commission has suggested the division of the country into seven power regions. This was endorsed by a meeting of the representatives of the State Electricity Boards D.V.C. etc. convetned by the Central Water & Power Commission for the purpose of considering the question of development of regional power grids.

(b) The recommendation will be considered by Government on receipt of the report of the deliberations from the Commission. A statement showing the main advantages of the scheme is laid on the Table of the House.

### STATEMENT

(i) Owing to diversity of load demands, an integrated system requires less generating capacity than that required by individual systems;

(ii) An integrated system requires less standby capacity than two or more systems operating independently;

(iii) Large generating stations including atomic power stations can be located at the most economical sites in the region as a whole;

(iv) Thermal stations can be used more effectively in conjunction with hydro-electric plants;

(v) Neighbouring systems could come to the aid of one another in times of emergency; and

(vi) An integrated system requires less capital and can be more favourably financed than two or more independent systems.
