STATEMENT

In order to meet the shortage of doctors in the country, all State Governments have been requested to arrange for an increase in the number of admissions in their medical colleges from the academic year 1963-64 upto a maximum of 200 wherever it can be done without lowering the standard of medical education so as to secure an overall increase of 3000 admissions every year. It has been decided to give financial assistance to the Governments for increasing the admission capacity under this scheme on the following pattern;

(i) Non-recurring (buildings and equipment)—Upto a Maximum of Rs. 15,000 per admission.

(ii) Recurring-Upto a maximum of Rs. 2000 per admission per annum.

The Central assistance under this Scheme will be outside the State Plan ceilings.

The Medical Council of India have recommended to all Universities to hold quarterly M.B.B.S. examinations so that the failed candidates may have an early opportunity to qualify.
