Visit of Joint Committee to Eastern U.P.

| Shri R. G. Dubey: | Shri Surendra Pal Singh: | Shri Bhakt Darshan: | Shri Bhagwat Jha Azad: | Shri Vishram Prasad: | Shri N. R. Laskar: | Shri Sarjoo Pandey:

Will the Minister of Planning be pleased to state:

- (a) whether a Joint Committee of the Planning Commission and the U.P. Government visited some parts of Eastern U.P. to investigate the causes of the poverty and backwardness there;
- (b) whether the said Committee has submitted any proposals; and
- (c) whether the Central Government propose to send similar teams to other areas in the country which are known as backward and chronically famine zones?

The Deputy Minister in the Ministry of Labour and Employment and for Planning (Shri C. R. Pattabhi Raman): (a) Yes, Sir.

- (b) The Joint Study Team is at present engaged in studying the data already collected and collecting from the State Government some fresh data bearing on the problems of economic and social development of these areas.
- (c) There is no such proposal for consideration by the Planning Commission.
- Shri R. G. Dubey: Who were the members of this Committee and what were its terms of reference?
- Shri C. R. Pattabhi Raman: They had to deal with and report, firstly, about wages, employment and levels, of living of low income groups in these areas; secondly, about measures for accelerated economic development particularly, for removal of pressure

on land through programmes of industrial development and development of transport and communications; and, thirdly about special provision for development of these areas in 1963-64.

- Shri R. G. Dubey: Are Government in a position to say whether some interim recommendations havebeen made by this Committee?
- Shri C. R. Pattabhi Raman: The study has been going on and their recommendations have been coming to us. They will all be collated soon and we expect that by September the report will be ready in the final form.
- Shri P. Venkatasubbaiah: May I know whether famine protection is as important as food production in the country and, if that is so, whether Government propose to assess the chronic famine-affected areas in the country and try to give some help to eradicate famine in those areas?
- Shri C. R. Pattabhi Raman: Certainly, Sir. Deep wells are being dug in places where they have to be dug. Minor irrigation programmes are also to be taken up in those areas which need those programmes urgently.

Shri Surendra Pal Singh: Is there a proposal under the consideration of the Government to start an applied nutrition programme in the eastern regions of UP under some arrangement with the UNICEF organisation of the UN? If so, what are the details of the programme?

Shri C. R. Pattabhi Raman: They have concerned themselves with certain districts of UP to start with as a study. It will then be extended throughout Eastern UP.

Shrimati Savitri Nigam: May I know whether the hon. Minister is aware that there are some backward areas in the south of UP, that is, the Bundelkhand area, and whether this scheme is going to be extended there or not?

Shri C. R. Pattabhi Raman: They are aware of the fact that there are

many areas in Eastern U.P. which are rather backward and they have . . .

Some Hon. Members: Southern U.P.

Shri C. R. Pattabhi Raman: . . . and also Southern U.P. I think the hon. Member is referring to the southern portion of Eastern U.P.

Some Hon. Members: Southern U.P.

Southern U.P.

श्री सरजू पाण्डेय: पूर्वी उत्तर प्रदेश के इन जिलों का सर्वे किया गया है, ग्राजीपुर, ग्राजमगढ़, देवरिया और जौनपुर । क्या माननीय मंत्री जी यह बताने की कृपा करेंगे कि उत्तर प्रदेश के जो ग्यारह जिले हैं, जो कि पिछड़े हुए कहे जाते हैं, उन के बारे में कोई जांच की जायेंगी या नहीं ?

्र योजना तथा श्रम श्रीर रोजगार मंत्री (श्री नन्दा) : जो टीम वहा पर गई है, वह इस किस्म के सवालों पर ग्रीर करेगी कि वहां की क्या समस्याएं हैं, क्या प्रावलम्ब .हैं। वह उन की टाइप स्टडी करेगी। उस में जो कुछ भी नतीजे निकलेंगे, जो भी कनक्लूजन्ब होंगे, उन का श्रमल दूसरे डिस्ट्रिक्ट्स में भी किया जायेगा।

श्री म० ला० द्विवेदी :द्वितीय श्रीर तृतीय पंच-वर्षीय योजनाश्रों में पिछड़े हुए क्षेत्रों की जांच पड़ताल श्रीर वहां की ग़रीबी को हटाने के लिए योजना बनाई गई थी । में यह जानना चाहता हूं कि जो कमेटी जांच करने के लिये गई थी, वह केवल पूर्वी उत्तर प्रदेश में क्यों गई श्रीर वह दूसरे पिछड़े हुए इलाकों में क्यों नहीं गई श्रीर वहां पर काम क्यों नहीं हो रहा है।

श्री नन्दा: देश के कुछ दूसरे प्रान्तों में भी इस किस्म का कुछ काम हो रहा है। दूसरे प्रान्तों से इस बारे में मसाला इकट्ठा करने के लिये कहा गया है, भीर वे कर भी रहे हैं, कि कौन से डिस्ट्रिक्ट्स बैंकवर्ड कहे जाने चाहियें, इस के क्या काइटेरिया होने चाहिएं, क्या इन्डीकेटर्ज हैं इस बारे में उन को बताया गया है कि क्योर उस की बिना पर वह सूचना इकट्ठी कर रहे हैं। उन के कुछ डिस्ट्रिक्ट्स उस ढंग से बैंकवर्ड डिक्लेयर किए गए हैं। उस के सिवा क्योर भी कुछ न कुछ एन्क्वायरी हो रही है।

श्री रा० शि० पाण्डेय : मध्य प्रदेश में विशेषकर झाबुद्या भीर सरगूजा, ये दो जिले ऐसे हैं, जहां पर श्रादिवासियों की दशा दयनीय है । में यह जानना चाहता हूं कि क्या उन के बारे में इस प्रकार की कोई कमेटी बनाई जायेंगी ।

ग्रध्यक्ष महोदयः यह सवाल तो सिर्फ़यु०पी०काहै।

Shri N. R. Laskar: May I know the main consideration for taking up the case of U.P. alone to begin with and not the other known backward areas?

ग्रध्यक्ष महोदय : इस सवाल को तो यू॰ पी॰ तक ही रहने दीजिये ।

डा॰ महादेव प्रसाद : माननीय मंत्री जी ने स्रभी बताया कि पूर्वी उत्तर प्रदेश में सर्वेक्षण के लिए कुछ टाइप निश्चित कर लिया गया। में जानना चाहता हूं कि उस टाइप को निश्चित करने का स्राधार क्या था।

श्री नन्दा: यू०पी० गवर्नमेंट के साथ मश्वरा कर के ऐसा किया गया था।

Dr. K. L. Rao: May I know whether it is a fact that the causes of poverty in the U.P. are well known and what is required is implementation of remedial measures?

Mr. Speaker: That is a suggestion.

Shri Basumatari rose-

Mr. Speaker: Why should he ask a question about U.P.?

Shri Basumatari: Why question is not like that. I want to know the

main reason for constituting the committee to enquire into the backward areas in the U.P. only and not in other States while so many backward areas are there?

Shri C. R. Pattabhi Raman: The position is this. The Planning Commission have been in correspondence with all the States. Nine States have not yet replied. They were asked to indicate (a) the backward areas and (b) what they thought were the areas which need accelerated help either from the Planning Commission or from the States.
