Will the Prime Minister be pleased to state:

- (a) whether it is a fact that a Nehru Memorial Fund has been launched;
- (b) if so, how this Fund is likely to be utilised:
- (c) the total amount so far received in the Fund; and
- (d) how many banks have been authorised to receive contributions to the Fund?

The Parliamentary Secretary to the Prime Minister (Shri Lalit Sen): (a) and (b). Yes, Sir. On June 27, 1964, the President issued an Appeal for contributions to the Jawaharial Nehru Memorial Fund which will aim at promoting the purposes were dear to the heart of Jawaharlalji. A National Committee of the Fund has since been formed with the President as its Chairman and many other leading citizens as its mem-The National Committee has decided to constitute a Trust in this connection and has also set up Programme Sub-Committee to formulate concrete schemes for which the Fund might be utilised,

- (c) According to the latest information available with the Memorial Fund authorities, the total amount received upto August 14, 1964, was Rupees eight lakhs and thirty-four thousand.
 - (d) Nineteen so far.

Shri Rameahwar Tantia: May I know the reasons for this poor response for a memorial fund to a great leader of the nation, whether it is on account of wrong approach, and if so, what methods Government are thinking of taking for collecting a decent amount?

The Prime Minister and Minister of Atomic Energy (Shri Lal Bahadur Shastri): The hon. Member should know that this committee, as also the collections sub-committee, were recently formed. The collections sub-committee has yet to start its work. It is meeting on the 17th, and discussing with some people also. Secondly, Government directly cannot make collections. I have no doubt that there will be full and hearty response from the people for contribution to this memorial fund.

Shri Rameshwar Tantia: What is the biggest amount received so far from a single firm or company?

Shri Lal Bahadur Shastri: I do not attach much importance to the biggest amount. One rupee is as important and valuable as one lakh.

Shri G. Mohanty: May I know whether an organisation has been set on foot to push on collections?

Shri Lal Bahadur Shastri: Yes.

Shri Bishwanath Roy: In view of the love and affection showed by the general public to the late leader, may I know whether any agency would be set up at the district level so that ordinary peasants and others . .
