Shri Shivaji Rao S. Dechmukh: Would the Government be pleased to consider it, on compassionate and humanitarian grounds—the first Prime Minister of India is supposed to have led eventful moments in this very House—justifiable to convert Parliament House building as memorial to the late Prime Minister and, if not which considerations are involved in his residence being memorialised?

Mr. Speaker: Order, order; we are very responsible persons being watched by the nation as a whole and, more particularly, by the visitors that are there. We should not indulge in such questions that might be the subject of ridicule by others.

Shri Shivaji Rao S. Deshmukh: May I plead with you.

Mr. Speaker: Order, order. Shrimati Reddy.

Shrimati Yashoda Reddy: May I know from the hon. Prime Minister, apart from the great love sentiment, we attach to our late Prime Minister and apart from the fact that Shri Lal Bahadur Shastri has said that he is much smaller with which we do not agree, whether it was a correct precedent to have made the official residence σť the Prime Minister a memorial, because tomarrow a President or a Prime Minister could say that he does not want to stay in any official residence? Is this a correct precedent and is there such a precedent anywhere in the world that the official residence of a Prime Minister has

been made a nathonal memorial after his death?

(b) International Telex Services to foreign countries, including New Zealand, operated by the Overseas Communications Service are already available to subscribers at Bombay, Ahmedabad, Calcutta and New Delhi, Subscribers at Madras will also have similar facilities very shortly.

Shri R. G. Dubey: May I know the expenditure involved in this project?

Shri Bhagavati: No extra expenditure is involved in this project because this is merely an extension of the Indo-British direct telex link with New Zealand.

- (c) if so, the broad features of the proposal under consideration or of the action already taken?

The Minister of Information and Broadcasting (Shrimati Indira Gandhi): (a) to (c). A statement is laid down on the Table of the House. [Placed in Library. See No. LT-3105/64].

Dr. L. M. Singhvi: May I know whether the Minister would outline for us the various matters which are being considered for inclusion in the terms of reference of the proposed committee, the extent and scope of its functions and whether the committee would be entitled also to recommend that the broadcasting operations of this country should be run under a public corporation?

Shrimati Indira Gandhi: This matter, as I have said is under consideration. We want to have a whole-time committee of knowledgeable persons who will go thoroughly into the working of all the units of the Ministry. The terms of reference are still being considered and will be shortly finalised.

Mr. Speaker: Is there a proposal to form a Corporation also?

Shrimati Indira Gandhi: The Committee is at liberty to suggest it.

Dr. L. M. Slaghvi: The common complaint against the broadcasting operations in this country is that they have fallen into bureaucratic grooves and, as a consequence, the external and the domestic publicity has suffered considerably. Would the Minister say whether the Government has any thinking in this matter and that thinking is being referred to this committee for further evaluation and assessment?

Shrimati Indira Gandhi: As I said earlier, the terms of reference be as wide as possible and it is for the committee to go into all these matters. It is a matter of opinion whether these media have gone down in quality. I do not think so.

Shrimati Savitri Nigam: How far is it correct that many of the experts have expressed the opinion that the formation of a committee will be delaying the action and how far is it correct that much of the criticism which has been recently made has been not based on facts but has been designed by a couple of prejudiced people?

Shrimati Indira Gandhi: There has been all kinds of criticism both in this Rouse and in the press, Naturally, I cannot say how much of it is bissed. Shri S. C. Samanta: The statement shows that many helpful suggestions have come to the Ministry about efficiency and functioning of the All India Radio. May I know whether those things will be placed on the Table of the House pointing out which have already been accepted.

Shrimati Indira Gandhi: Some of the points are already outlined in the statement and as this Committee proceeds with this work, we will naturally keep the House informed.

Shri Subodh Hansda: Besides there being news bulletins through the medium of English and other State languages, I would like to know whether there is any arrangement to broadcast news through any of the dialects?

Shrimati Indira Gandhi: I think already a number of dialects are used.

## Mr. Speaker: Suggestion.

Shri Hari Vishnu Kamath: When the Minister recently said that the British time pattern, functioning and set-up of the All India Radio had not been re-oriented to the democratic conditions of independent India, was she conscious that indirectly she was criticising the policy and programme of her own father, the late

Prime Minister and, if so, since the massive Chinese invasion, when she became Chairman of so many committees, the Citizens Committee, the National Defence Council, the Integration Committee, etc., Why, during the last two years, did she not make any suggestion for improving the functioning of the A.I.R.?

Mr. Speaker: He can get information from a Minister, not about what happened when she was a Chairman of some Committee.

Shrt Hari Vishnu Kamath: She was the Chalrman of important Committees, the Citizens Committee, the National Defence Council . . .

Mr. Speaker: He has to put a question about her Department

Shri Hari Vishnu Kamath: Yes. When she was the Chairman of these Committees, before she became the Minister, why did not she make a suggestion for improving the All India Radio?

Mr. Speaker: I don't allow it Shri Nath Pai.

Shri Hari Vishnu Kamath: If you do not allow my question, may I put a different one?

Shri Nath Pai: Pending the finalisation of the terms of reference of the Committee to which the Minister has made a reference in her statement, may I know whether she is contemplating taking any remedial steps by way of mitigating, by way of removing, at least a part of the seething discontent in the All India Radio as a result of the alleged favouritism, nepotism and arbitrary appointments of staff artistes?

Shrimati Indira Gandhi: This is a questionable statement, Sir. But we are certainly in touch with the staff of the Ministry and if there are any complaints, we will look into them.

Shri P. C. Borocah: May I know whether there is any sheeme to shift the emphasis from radio to television and, if so, what it is? Shrimati Indira Gandhi: No, we cannot shift the emphasis, because we have not started television except on a very small scale.

Shri Vidya Charan Shukla: Is it a fact that the hon. Minister said: in a speech a few weeks ago that All India? Radio was considering the question of starting a commercial service in a restricted manner, and if so, what the lines of thinking in that regard are?

Shrimati Indira Gandhi: No, I did not say that.

Shrimati Renn Chakravarity: The statement says that departmental committees have been set up in order to go into the conditions of staff artistes. May I know whether there is any proposal to set up expirit committees which will really go into this whole question of appointments and other matters and also the question of the DG's powers which are very wide and fur-flune?

Shrimati Indira Gandhl: I have already mentioned that we are having an expert committee which will go into every aspect of the working of the Ministry.

Shri Hem Barua: May I know whether the attention of Government hatbeen drawn to the criticisms made recently by the Plan Publicity Committee to the effect that there are certain glaring lacunae in the working of the Government publicity machinery and that the Government publicity machinery is interested in giving greater publicity and greater importance to the dull, drab and dry speeches of the Ministers and neglects generally.

Shri Raghunath Singh: There are so many adjectives in his question.

Mr. Speaker: Let him have the satisfaction that he has said that.

An hos. Member: What is the use of so many adjectives?

Mr. Speaker: The hon. Member can say, instead of putting in so many adjectives, that instead of giving greater publicity to the speeches of the Ministers, they should give publicity to other things. He need not put in so many adjectives which were not needed to make the question intelligible.

**Shri Hem Barua:** That is the impression in the country, and that is the impression among

Some hon. Member: No.

Mr. Speaker: No adjectives are to be used unless they are required to make the question intelligible. In this case, the question was otherwise also intelligible.

Shri Hem Barua: May I submit that adjectives are for use and not for cold storage.

Mr. Speaker: Does the hon. Member want to ask any supplementary question or not?

Shri Hem Barua: Yes.

Shri S. M. Banerjee: He has a buffer stock of adjectives

Shri Hem Barua: The record says that the publicity machinery gives greater importance to the speeches of Ministers and neglects real publicity so far as matters concerning the interests of the nation are concerned. If so, may I know whether belong the report of this proposed committee is finalised, Government propose to take certain interim measures towards the improvement of the working of this publicity machinery of Government?

shrimati Indira Gandhi: If the hon. Member will read the statement he will find that we have said there that the Ministry agrees with the observation that AIR is not only a spokesman of Government but has a moral obligation to serve as the voice of the people.

Shri Hem Barus: May I suomit that the hon. Minister has not replied to the important point of my question? So may I ask for your permission, to ask this question? Mr. Speaker: Why should he ask for my permission, now? When he had not obeyed what I had said serlier he need not ask for further permission. If he asks for it then I would say that I request him to say nothing further, and he should resume his seat.

Shri Hem Barua; May I submit for your consideration

Mr. Speaker: I am submitting for the hon. Member's consideration that he may kindly resume his seat.

Shri Hem Barua: I agree to sit down, but the hon Minister has not replied to the important point of my question.
