Mr. Speaker: Nothing has been settled with regard to the fifth. If this is settled earlier this will be fifth.

Rail Communication in Assam

Will the Minister of Railways be pleased to state:

- (a) whether he visited Assam in January this year to make a personal study of the needs for augmenting the rail communication in that State;
- (b) if so, the result of his study; and
- (c) the schemes which are to be taken up during the ensuing year for augmenting the rail communications in that area?

The Deputy Minister in the Ministry of Railways (Shri Sham Nath):
(a) Yes, Sir. The Minister for Railways did visit Assam in January, 1965; and study of the needs for augmenting rail communications in Assam was only one of the many points, which the Minister was concerned with.

(b) and (c). Several schemes are under implementation for augmenting the transport facilities to Assam. The broad gauge line is being extended from Siliguri to Jogighopa. Simultaneously, the ferry capacity at Khejuria|Farakka Ghat is being increased from 200 to 400 B.G. wagons Centralised Traffic Control, a modern form of Signalling, is being provided between Bongaigaon Gauhati, to increase the capacity of the existing metre gauge section. Major yard remodellings at Lumding, Tinsukia, Alipur Duar, Rangiya and Siliguri as also line Capacity in the section between Chamagram and New Jalpaiguri have either sanctioned or are in progress.

In addition, the Ministry of Transport have plans for augmentation of the road as well as river transport capacity beyond Bonga'gaon|Jaglghopa, including development of an inland port, at Jogighopa.

With all these measures, the transport capacity of Assam is expected to become double of what it is now. The problem will, however, be kept under continuous watch by the Railway Ministry as well as the other concerned Ministries of the Government.

श्री शासनाथ: इसी वजह से तो चार पांच चीजें जिनका कि मैंने जिक किया वह हमारे हाथ में हैं। यह कोशिश की जा रही है कि ट्रान्स-पोर्ट कैपैसिटी ज्यादा से ज्यादा बढ़ जारे। इन तमाम स्कीमों पर तक़रीबन 68 करोड़ रपया खर्च होने वाला है।

श्री यशपाल सिंह : इस के ऊपर किसी दूसरे प्राविस से मदद ली जायगी या रेल मंत्रालय बगैर किसी ठेकेदार के या मिडिल-मैन के इस काम को करेगा ?

श्री शामनाथ : श्रव इस में तो ऐसा कोई सवाल उठता नहीं है कि किसी दूसरी स्टेट से मदद ली जारेगी या नहीं वयोंकि रेलवेज का भपना एक खृद का तरीक़ा काम को करने का होता है वह तरीका ही इस्ते-माल किया जायगा। भी यश्चापाल सिंह : मैं यह जानना चाहता हूं कि क्या मिडिलमैंन को भौर इस टेकेटा तथा को खत्म किया जायगा ?

Shri Priya Gupta: In view of the statement of the hon. Minister about the augmentation of the intermediate part of the transportation link and sending the entire transport materials up to Jogighopa, what improvements do the Railway Ministry feel have got to be made for pushing the same loads towards upper Assam, from Jogighopa to Dibrugarh side? May I know whether the broad-gauge line will be extended from Gauhati through a shorter route to upper Assam (Dibrugarh) via Golaghat with a bridge over Brahmaputra in upper Assam?

The Minister of Railways (Shri S. K. Patil): As it is, the people of Assam have set their heart on the business of having a broad-gauge line. It will come one day. But the traffic must develop and it must get the necessary priority. These measures are interim measures; not final measures. I am quite sure in due time the broad-gauge will come to Assam.

श्री हुकम चन्द कछताय : मैं जानना चाहता हूं कि यह परिवहन सेवाएं कब तक पूरी हो जायेंगी और जनता को कब तक इन की सहूलियत मिलने, लग जायेंगी ? इस में कितना समय लगेगा ?

भी स० का० पाटिल : प्रव यह रेल कम्युनिकेशन को सुदढ़ करने भीर उसके विस्तार करने का काम तो चलता ही रहता है क्योंकि कभी भी वह एकदम पूरा नहीं होता है क्योंकि उसके साथ ही साथ जरूरतें भी बढ़ती चली जाती हैं इसलिए यह काम वो हमेशा चलने वाला है।

भी रामेक्बरानन्द : घसम में रेलों के विस्तार के जो प्रयत्न किये जा रहे हैं यह बहुत घच्छी बात है लेकिन क्या चीन की विस्तारवादी नीति धौर दबाव को देखते

हुए भारत की उत्तरी सीमाग्रों पर भी रेलवे का विस्तार किया जा रहा है या नुहीं ?

रेलवे मंत्रालय में राज्य-मंत्री (डा॰ राम मुभग सिंह): सिलीगुडी से जो लाइन पूर्व की घोर जाती है वह लाइन प्रव रंगापाड़ा से नौर्य लखीमपुर घोर नौर्य लखीमपुर से मरंकोंग सेलक तक बढ़ाई जा रही है जो कि पासीघाट से 20 किलोमीटर या उस से कुछ प्रधिक है।

Shrimati Renu Chakravartty: In view of the fact that much of the transport is being taken by roads and by steam ships, is there any proposal to make the line from Bongaigaon to Jogighopa broad-gauge in order to carry the extra load?

Shri S. K. Patil: It is already in the process of becoming.

Shri Bishwanath Roy: In view of the strategic importance of the State, may I know whether in the Fourth Plan period some more new lines would be constructed in that area?

Shri Sham Nath: I have already mentioned the schemes that are in hand

Railway Minister as also of the Minister of State for Railways to Assam it was represented that the broad-gauge line should be extended up to Gauhati and, in view of the fact that the extension up to Jogighopa was in the context of defence and not so much of commercial loss or gain for the Railways, whether they are considering the extension of the broad gauge line up to Gauhati?

Shri S. K. Patil: Both the considerations are before our eyes. It is not for defence alone that it is being done, but communications also are not up to the standard in that eastern State. Therefore both these are kept in view

Shri S. T. Singh: May I know whether the Minister of Railways has a scheme to touch at least the border of Manipur through Cachar?

Dr. Ram Subhag Singh: This request is being repeatedly made by the Government of Manipur. It is a fact that they are in need of some better type of communications. There are two or three railheads in the District of Cachar and we will examine as to how best to serve the needs of Manipur from there

Shri Basumatari: In view of the frequent threatening from the Chinese, may I know whether our Minister felt it necessary that there should be a second railway line alongside the border with Bhutan which should go up to NEFA from the point of view of defence?

Dr. Ram Subhag Singh: The line which goes from Siliguri to Murkong Selok is just near the foothills. At places it is very near Bhutan and further east it touches the area of NEFA. It is only 20 miles or so from Pasighat. The demand is that it should be extended up to Pasighat. I think, the other broad-gauge line which is under construction from

Farakka side to Jogighopa serves the purpose because there are now two links

Explanations for alleged lapses have been received from persons concerned and are in various stages of examination.

- (c) Measures already taken to reorganise the Corporation, tighten up security arrangements and strengthen fire fighting arrangements are designed to avoid similar incidents.
