

experienced in implementing the decision, partly owing to lack of suitable office and residential accommodation at the places to which it was proposed to shift the offices and partly because of the reluctance on the part of the offices concerned to move out of Delhi on the ground that work will suffer.

(c) Some of the offices to be shifted out of Delhi are now proposed to be moved to Faridabad where phase I of the construction programme is nearing completion. It is also proposed to accelerate the construction of office and residential accommodation in Faridabad phase II and in Ghaziabad for such offices.

(b) In or near Delhi, in 1965-66.

(c) Rs. 1,76,000 per annum recurring and Rs. 20,000 non-recurring.

(d) The terms and conditions of UNICEF assistance for the programme are still under consideration.

#### Business transacted by L.I.C.

\*1213. **Shri Alvares:** Will the Minister of Finance be pleased to state:

(a) whether the Life Insurance Corporation transacted less business during 1964-65 than in the previous year;

(b) the reasons for this loss in aggregate business; and

(c) the remedies that Government propose to increase business upto expectations?

**The Minister of Planning (Shri B. R. Bhagat):** (a) The new business completed by the Corporation during the year 1964-65 amounted to Rs. 701 crores as compared to Rs. 702.76 crores during 1963-64.

(b) The short-fall compared to the previous year is marginal in nature. No special reasons can be adduced for this marginal shortfall.

(c) The Life Insurance Corporation is alive to the need to increase substantially the volume of new business. Government are also studying the position in order to be able to render such assistance to the Corporation as it may require in this respect.
