Tr. Chandrabhan Singh: *777. { Shri Vidya Charan Shukla: Shri R. S. Pandey:

Will the Minister of **Petroleum ana Chemicals** be pleased to refer to the **reply** to Unstarred Question No. 466 on the 25th November, 1964 and state:

(a) whether the Government have completed negotiations regarding commercial exploitation of Hamycin with foreign collaboration;

(b) whether the agreement has also been signed with some firms; and

(c) if so, the broad outlines of the agreement?

The Minister of State in the Ministry of Petroleum and Chemicals (Shri Alagesan): (a) The negotiations with foreign firms are continuing.

(b) and (c). Do not arise.

Shri Ranga: What is this substance?

Mr. Speaker: It is for doctors.

Dr. Chandrabhan Singh: At what stage are we in the negotiations?

Shri Alagesan: The drug has been sent to foreign firms, especially a firm in USA. They have held largescale clinical trials and have found the results very encouraging. It is likely that we will enter into an agreement with them, and then this will be put on the market.

Shri Kapur Singh: I want to know whether the initial claim of the Government that this concoction cures dandruff is still valid.

The Minister of Petroleum and Chemicals (Shri Humayun Kabir): If my hon. friend wants to make the experiment, we shall give him all facilities.

Shri Kapur Singh: That is not my juestion.

Mr. Speaker: That is the opinion of Government.

Shri Kapur Singh: It is not a question of opinion. This was the claim officially made. That claim cannot be sustained. I want to know whether they still stick to that claim.

Mr. Speaker: Did Government make that claim that it is a curative for dandruff?

Shri Alagesan: That I do not find. It is a cure for oral thrush in children.

Mr. Speaker: Government did not make that claim.

Shri Kapur Singh: The literature which they issued to the foreign countries makes that claim.

Mr. Speaker: If he is not making that claim now.....

Shri Hari Vishnu Kamath: He said 'oral', and then swallowed some thing, some words perhaps.

Shri Kapur Singh: Are we going to mislead foreigners?

Mr. Speaker: Now they would not be mislead since that question had been put. Next question.

Training of Cadets in Delhi Schools

*779. Shri Indrajit Gupta: Will the Minister of Education be pleased to state:

(a) whether it is a fact that there are no trained commissioned officers to instruct NCC (Army Wing) cadets in many Government Schools in Delhi;

(b) whether it is also a fact that commissioned officers are often posted to schools where there are no NCC Cadets; and

(c) if so, the manner in which Government propose to rectify this situation?

The Minister of Education (Shri M. C. Chagla): (a) and (b). No, Sir.

(c) Does not arise.

Shri Indrajit Gupta: Is it not a fact that a large amount of money is being spent on the training of these new teachers, trained commissioned officers but they are not being posted to schools where NCC Cadets are sent for training?

Shri M. C. Chagla: These teachers are not merely NCC teachers in the sense that they do not merely train the NCC boys; they are ordinary teachers getting ordinary training; they get a special allowance of Rs. 250 for doing NCC work. If they get promotion, they are transferred to some other school and another NCC trained person has to come. Sometimes it does not happen and there is a slight time lag and the result is that there might be vacancy for a few days or a few weeks. Shri Indrajit Gupta: May I know specially whether in the Delhi area there are a number of schools where the NCC Cadets are available but there are no trained teachers of the type which the hon. Minister has referred to?

Shri M. C. Chagla: As I said, my information is that there are teachers in all the schools in the Delhi Administration. There may be instances where for a few days or weeks some teachers may not be available.
