The Minister of Planning (Shri B. R. Bhagat): (a) An agreement between the Governments of India and Austria was signed on 5th April, 1965 for a credit of 104 million Austrian Shillings. This credit was offered earlier by Austria at the Consortium meetings convened under the auspices of the World Bank.

(b) The credit bears interest (a) 5½ per cent per annum and is repayable in twenty equal half-yearly instalments commencing from January 1st, 1970.

(c) We are free to select goods of Austrian origin for being financed under the Credit.

(d) the States whose per capita income fall below the average?

The Minister of Planning (Shri B. R. Bhagat): (a) Yes, Sir. The results are given in the book titled "Distribution of National Income by States, 1960-61", published by the National Council of Applied Economic Research.

(b) Estimates of the Council are at considerable variance with similar estimates prepared by the State Statistical Bureaux. It is not possible to say to what extent the Council's estimates are reliable.

(c) The national average per capita income was Rs. 325.7 in 1960-61, according to official estimates. The Council's estimate for the same year is Rs. 334.54.

(d) According to the Council's estimates, the States/Union Territories with per capita income falling below the national average are Madras, Assam, Tripura, Himachal Pradesh, Kerala, Mysore, Uttar Pradesh, Jammu & Kashmir, Andhra Pradesh, Madhya Pradesh, Orissa, Rajasthan and Bihar.
