- (a) whether the Study Group appointed by the Centre to examine the organisational and financial aspects of the Rajasthan Canal Project, has submitted its recommendations to the Union Government; and
- (b) if so, the main recommendations made by this Study Group in this regard and the Central Government's reaction thereto?

The Minister of Planning (Shri B. R. Bhagat): (a) Yes, Sir.

(b) The Study Group has made certain tentative proposals which are under consideration and a view has yet to be taken on them.

Shri Sham Lal Saraf: Apart from being the main source of irrigation to vast tracts of land in that region, may I know whether the study group has confirmed in that report that they may be connected with the eastern and western parts of the country for navigtation purposes also? Is that also one of their recommendations?

Shri B. R. Bhagat: That is not under the present phase of examination. That may be a long-term aspect.

Shri Hem Raj: May I know whether the Rajasthan Canal will be given water from these two projects, the Beas project and the Sutlej-Beas link, and since the people of those areas are being ousted even before the irrigation project or policy has been fina-

lised, may I know whether the responsibility is going to be taken over by the Central Government or be given over to the Rajasthan Government?

Shri B. R. Bhagat: When the proposed authority is created, it will look into this question also.

Shri Bibhuti Misra: May I know whether it is a fact that the Central Government is going to take in its pool the Rajasthan Canal, the Gandak Project and some other projects of South India?

Shri B. R. Bhagat: The question relates to Rajasthan.
