to 1961 is not available Fresh U.K. investments worth Rs. 36:92 crores were approved by the Government of India during the period 1962 to 30th September, 1965.

- (b) No amount was remitted to the U.K. by way of repatriation of capital during the period January to March 1985. Information subsequent to March 1985 is not yet available.
- (c) Government do not feel that the prospects of British investments in India are likely to be significantly affected as a consequence of this fact

*606. Shri D. C. Sharma: Will the Minister of Health be pleased to state:

- (a) whether it is a fact that the C.G.H.S. doctors submitted a memorandum to the Prime Minister asking for his intervention in their Case of service conditions and emoluments; and
- (b) if so, the action taken in the matter?

The Minister of Health (Dr. Sushila Nayar): (a) and (b). A memorandum was submitted to the Prime Minister by some officers of the Central Health Service. It was represented in the memorandum that there should be no qualifying test for promotion from Class I of the C.H.S. to General Duty Medical Officers Class I Grade. This matter had been considered by the Government of India earlier and it was decided that as a rule there should be a qualifying test with a view to ensuring in doctors promoted to Class I a certain minimum necessary professional competence.

Credit to Sudan

- (a) whether the discussion with the Government of Sudan to extend a credit of Rs. 5 crores for setting up industries has been finalised; and
