(b) if so, the broad outlines thereof?

The Minister of State in the Ministry of Finance (Shri B, R. Bhagat):
(a) No. The existing provisions of the Banking Regulation Act, 1949, provide for an adequate degree of control by the Reserve Bank of India over the working of the banks and it does not appear to be necessary at present to impose stricter control.
