The Minister of External Affairs (Shri Swaran Singh): (a) Yes, Sir.

(b) and (c). Our information is that the economic exchanges between China and these countries do not involve items which would directly contribute to China's war potential. Since these, nowever, would lead to the strengthening of China's heavy industrial potential, the Government are maintaining a watch and in cases where it is felt that it would strengthen China's military potential, our views have been made known to the countries concerned.

The Minister of Defence (Shri Y. B. Chavan): (a) The scheme is still under consideration at the expert level.

(b) The present scheme under consideration being a limited one, consideration of difficulties in the way of compulsory conscription does not arise at this stage.

Bifurcation of Navy into two Commands

*21. Shri A, S. Alva: Shri M. K. Kumaran:

Will the Minister of **Defence** be pleased to state:

- (a) whether Government propose to bifurcate the Navy into two commands, one for the East Coast and the other for the West Coast;
- (b) if so, whether the details have been worked out and the location of the respective commands contemplated; and
- (c) whether such bifurcation will be conducive to the better management of the Navy and increase its efficiency?

The Minister of Defence (Shri Y. B. Chavan): (a) to (c). The Navy is already divided into three commands under Operational Control Authorities who are responsible for all Naval operations in their respective areas of

sea jurisdiction. The principal units of the Navy are, however, organised as one Indian Fleet. Government are engaged in the task of modernising and building up of the Navy to enable it to play its role in the defence of the country and the Navy may have to operate both in the Bay of Bengal and in the Arabian Sea.

A.I.R. News Bulletins

- *23. Shri P. C. Borooah: Will the Minister of Information and Broadcasting be pleased to state:
- (a) whether the Central Programme Advisory Committee at its meeting held on the 12th April, 1966 recommended an improvement in the pattern of A.I.R. News-Bulletins to make them 'Brighter and Better';
- (b) if so, the broad lines on which the bulletins were proposed to be improved and patterned; and
- (c) the steps taken by Government in that direction?

The Minister of Information and Broadcasting (Shri Raj Bahadur): (a) Yes, Sir. Some members were of the view that the news broadcasts by A.I.R. were dull and suggested an improvement in their form and content.

(b) and (c). Continuous efforts are made to exclude routine news or news of dull nature as far as possible. Also, consistent with national interest, the news spectrum is constantly widened so as to include news of greater interest and variety. Special attention is being paid to the drafting of news stories so as to make them brief, complete and balanced. As explained to the members of the Central Programme Advisory Committee, A.I.R. has to select news that is available to it from the various sources at any given time. All news-worthy find their due place in its bulletins.
