Will the Minister of Railways be pleased to state:

(a) whether it is a fact that the cost of production of diesel locomotives at the Diesel Locomotive Works, Varanasi has gone up by more than 25 per cent as a result of devaluation;

(b) if so, whether this rise in cost has caused a drastic cut in diesel locomotives output and, if so, to what extent; and

(c) how the production after devaluation compares with that during the corresponding period last year?

The Minister of State in the Ministry of Railways (Dr. Ram Subbag Singh): (a) No, Sir.

(b) Does not arise.

(c) In the 5 months since devaluation viz. June to October, the production was 17 locos as compared to 19 in the corresponding five months of last year. The lower out-turn this year was due to the shortage of axles and not devaluation. But for this, the out-turn during the former period would have been 25 locomotives.
