Foreign Interference in Assam Affairs

*571. Shrimati Tarkeshwari Sinha: Shri Vishwa Nath Pandey: Shri H. C. Linga Reddy: Shri P. R. Chakraverti: Shrimati Savitri Nigam: Shri Mohan Swarup: Shri Bibhuti Mishra: Shri K. N. Tiwary: Shri P. Will the Minister of Home Affairs be pleased to state:

- (a) whether his attention has been drawn to the statement made by the Chief Minister of Assam, that because of the interference of foreign powers, the problem of Assam is becoming more and more complicated; and
- (b) if so, the steps taken by Government to see that Government machinery in Assam is not immobilised by the said interference?

The Deputy Minister in the Ministry of Home Affairs (Shri Vidya

Charan Shukia): (a) According to information furnished by the Government of Assam no such statement has been made by the Chief Minister. During the last session of the State Legislative Assembly, however, on a number of occasions the Chief Minister had to refer to subversive activities of the enemy agents within the State.

(b) To meet such activities all concerned authorities have been alerted to be constantly vigilant and the public also have been alerted through appeals etc.

Shrimati Tarkeshwari Sinha: May I know whether Government's attention has been drawn to the fact that these activities are very much organised with the connivance of the foreign plantation proprietors, and if so, what specific action Government have taken so far to see that these kinds of mischievous activities are not indulged in by these foreign plantations?

Shri Vidya Charan Shukla: According to our reports, no such specific instance has come to our notice where foreign planters have been involved in these activities.

Shrimati Tarkeshwari Sinha: May I know whether Government's attention has been drawn to the fact that these tribal areas have a direct link with various organisations in Pakistan, and if so, how Government propose to mop up these kinds of activities so that the Pakistani link could be completely eliminated from those areas? May I know whether Government propose to strengthen the administrative machinery in these tribal areas which are infected by these Pakistani agents?

Shri Vidya Charan Shukla: Yes, the hon. Member is quite right; there

are some groups like the Mizo hostiles and Naga hostiles, which have contacts with the Pakistan authorities. Several times we have answered this question in the House regarding the measures that we have taken to stop these activities and strengthen our borders so that these contacts are eliminated and reduced.

Shrimati Tarkeshwari Sinha: May I know whether any specific steps have been taken in view of that, and whether they are being taken at the present moment?

Shri Vidya Charan Shukla: Yes, they have been taken before and they will be taken.

Shrimati Tarkeshwari Sinha: What specific steps have been taken?

Shri Vidya Charan Shukla: We have increased our border security forces, posts, watch-towers and many other things. All that has been described here earlier.

भी विश्वनाथ पाण्डेय : श्रीमन्, प्रभी माननीय उपमंत्री ने बतलाया कि श्रसम के मुक्य मंत्री ने ऐसा नहीं कहा है ऐसा वक्तव्य या इस तरह की कोई चीज उन्होंने प्रकाशित नहीं की है लेकिन देखने में श्राया है श्रीर श्रक्षवारों में पढ़ने में श्राया है कि पूर्वी पाकि-स्तान से बहुत से घुसपैठिये श्रसम में भाये हैं श्रीर वह रहते भी हैं श्रीर श्रसम सरकार के कार्यों में श्रहचन भी लगाते हैं तो इस के सम्बन्ध में सरकार की क्या प्रतिक्रिया है?

श्री विद्या चरण गुरल: जो हां श्रध्यक्ष महोदय, इंस तरीक़ के खुसपैठिये ईस्ट बंगाल सं श्रमम में श्राये हैं भीर उनको रोकने के लिए मभी संभंव कार्यवाही की जा रही है। श्रभी जिस तरीक़े की घुसपैठियों की कार्यवाही कुछ बढ़ी थी उस के लिए श्रभी कुछ एसी कार्यवाही की गई है जैसे कि बीरकर सीक्यो-रिटी फोर्स बनाई गई है। कुछ भाउट-पोस्ट्स गांलपाड़ा में जहां कि इस तरह की देश विरोधी चीज देखी गई थी वहां कायम की गई श्रीर वहां इस सम्बन्ध में विशेष प्रीकाश्चंस लिये गये हैं।

Shri P. R. Chakraverti: Keeping in view the serious situation created by continuing infiltration from East Pakistan into Assam, may I know what effective steps have been taken by Government to clear off a two-mile belt along the whole border, as had been promised earlier?

Shri Vidya Charan Shukla: Various measures were considered for purpose, one of them being what the hon. Member has indicated, namely removing the population from twomile belt along the entire border. But in view of the severe human misery involved and other attendant blems, it has not been implemented. There was also the question of sealing the border by barbed wire fences. But after a good deal of consideration with the Assam Government as well as among ourselves, it was found out that it wou'd not be as effective as we would like it to be. So the most effective measure which could produce immediate result was to increase our vigilance all along the border. That we have done.

Shrimati Savitri Nigam: Keeping in view the very complicated situation, are Government intending to settle retired defence personnel and other people in some of those areas so that they could be a source of help to our inte'ligence department and other security personnel?

Shri Vidya Charan Shukla: We have a scheme of that kind under consideration and we have tried a pilot project in some border areas.

श्री विभूति मिश्रः क्या मरकार के ध्यान में यह बात झाई है कि झसम में, नागालैंड में, भी जो हिल्स में जो पादरी लोग रहते हैं उनका विदेशों से सम्बन्ध है श्रीर वे पादरी वहां की जनता को उकसा कर श्रीर भड़का कर श्रपनी एक चीन श्रीर हिन्दुस्तान के बीच में एक इंडियपेंडेंट स्टेट बनवा देना चाहते हैं। यह पादरी लोग इस तरह की कार्यवाही करते हैं श्रीर यू० एन० ध्रो० में भी इस तरीके का ध्रपना एक धावेदनपत्न देते हैं श्रीर यहां के लोगों को भी इस तरह से उकसाते हैं श्रीर पाकिस्तानी लोग जो हैं हम लोगों में भी कुछ ऐसे लोग हैं जो पाकिस्तानियों से मिले रहते हैं श्रीर जो कि ध्रसम के बाशिन्दे हैं श्रीर पाकिस्तान वाले भी धाते हैं। मैं जानना चाहता हूं कि गृह मंत्री जी इस सम्बन्ध में कौन सा कदम उठाना चाहते हैं ताकि उन सभी देश-द्रोही तरवों से छटकारा मिले।

धी बिद्या घरण भुक्ल: ऐसे कुछ पादरी हो सकते हैं जो कि इस तरह की उकसाने वाली कार्यवाहियां करते हों साथ ही ऐसे पाकिस्तानी और अराजक तस्व वहां हो सकते हैं लेकिन सभी पादरियों के बारे में इस तरह की बात कहना ठीक नहीं होगा। कुछ ऐसे पादरी अवश्य हैं जिन्होंने इस तरीक़े की कार्यवाही की है और उनके विख्य सरकार द्वारा कार्यवाही की गई है। एक ऐसे पादरी होते थे उनको हिन्दुस्तान से बाहर जाने का भी हुक्स दे दिया गया। बहरहाल इस तरह की देशविरोधी जो भी कार्यवाही करते हैं सरकार द्वारा उनके विख्य कड़ा से कड़ा कदम उठाया जाता है।

श्री क० ना० तिवारी: क्या यह सही है कि असम के मुख्य मंत्री ने जैसा कि डिप्टी मिनिस्टर साहब ने बतलाया उन्होंने यह भी सरकार को सूचना दी है कि यहां के पादरी राजनैतिक पार्टियों, मीजो विद्रोहियों भीर नागाओं से मिले हुए हैं जो नागाज श्रीर मीजोब पाकिस्तान से ट्रेंड होकर यहां था रहे हैं भीर उनके द्वारा यहां पर गोरिला वार की भी तैयारी की संभावना है तो सरकार इस सम्बन्ध में क्या कार्यवाही कर रही है?

श्री विद्या चरण शुक्त : सरकार को मालूम है कि यह मीजो नेशनल फंट के लोग पाकिस्तान के लोगों से मिले हुए हैं श्रीर इसलिए सरकार ने इस संस्था को गैर-कानूनी करार दे दिया है।

Shri P. C. Borooah: How for is the report correct that some money from

Pakistan has already come into Assam to be used in connection with the elections? If so, what measures are going to be taken to put a stop to that?

Shri Vidya Charan Shukla: We have no information.

Shri S. C. Samanta: May I know whether recently some searches were made in Assam and some incriminating papers discovered concerning foreign power interference?

Shri Vidya Charan Shukla: The only interference we have discovered so far is from the Pakistan side.

Shri Subodh Hansda: Are Government prepared to take over all the missionary institutions which are run by the missioneries in Assam, which are centres of these subversive activities, particularly in the tribal areas?

shri Vidya Charan Shukla: It is not possible nor desirable to suspect all the educational institutions. If we come across any instance of any institution being used for this purpose, we shall definitely take necessary action.

श्री म० ला० दिवेदी: जिन मंत्री जी ने भ्रभी हाल में गृह मंत्रालय का कार्यभार सम्हाला है वे पहले रक्षा मंत्री भी रह चके हैं ग्रौर उन्हें मालम है कि बोरडर स्टेट्स में किस प्रकार की कठिनाइयां होती हैं मैं जानना चाहता हं जैसा कि उपमंत्री महोदय ने मल प्रकृत के उत्तर में बतलाया कि सरकार के पास श्रपनी कोई जानकारी नहीं है ग्रीर ग्रसम के मध्य मंत्री ने बतलाया है कि उन्होंने वैसा कोई वक्तव्य नहीं दिया कि ऐसी घटनाएं वहां हो रही हैं तो मैं जानना चाहता हं कि क्या केन्द्रीय सरकार बोरडर में भ्रपने कोई ऐसे मूज नहीं रखती जिससे उसे मब जानकारी मिल सके ग्रीर वहां का तमाम ऐसी गतिविधियों का पता चल सके भीर हमारे देश को हानि पहुंचाने वाले तत्वों को निर्मल किया जा सके, यदि नहीं तो क्यों नहीं?

श्री विका चरण शुक्लः हमारे सूत हर जगह पर रहते हैं। श्री म० ला० द्विवेदी: ग्रध्यक्ष महोदय वह कहते हैं कि सूत्र रहते हैं। लेकिन पहले उन्होंने कहा कि उनके पास कोई सूचना नहीं है।

ग्रध्यक्ष महोदयः सूचनानहीं है। जो मूज रहते हैं प्रगर वह मूचना नहीं पासके, तो फिर क्या किया जाये।

Shri D. C. Sharma: I thank the hon-Deputy Minister for soft-pedalling the whole of this question. He said that there was nothing wrong with the planters, that though there were attempts, infiltration was under check. May I ask him one question? Is it not a fact that in spite of the good news that he has given on the floor of the House, the infiltration is on the increase, the number of persons who are being trained in Pakistan collusion with the Chinese is on the increase, and the spirit of insurrection is on the increase in these border areas? If it is so, is it not a fact that all the precautions and all the measures taken by the Government so far have proved to be ineffective?

Shri Vidya Charan Shukla: I would not say that our precautions have proved to be ineffective. I have myself said that recently we have noticed an increase in these infiltration attempts in Assam, and we are taking special measures to check them.

Shri Kapur Singh: I want to know which of our two well-known frineds on our borders is more virulently active against India in so far as the State of Assam is concerned.

Shri Vidya Charan Shukia: Pakistan.

भी सथ निषये: घष्टयक्ष महौदय, मंत्री महोदय ने कहा कि ग्रसम के मुख्य मंत्री के द्वारा इस किस्म का कोई वयान नहीं दिया गया था। लेकिन पिछले साल से पूर्वोत्तर सीमावर्ती रेलवे पर जो हमले हुए उनको लेकर सुरक्षा मंत्री ग्रीर रेलवे मंत्री डा० रामस्त्रमा सिंह ने कई बयान सदन के सामने पेश किये हैं। सरक्षा मंत्री ने कहा था कि फ्रांच माकाँ के राकेट मिले हैं जिसकी शव भी पूछ ताछ हो रही है भीर डा॰ राम सुभग सिंह ने कहा था कि विदेशियों के द्वारा उसमें हस्तकोप किया जा रहा है। तो मैं प्रार्थना करता हूं कि मंत्री महोदय इसकी पूरी इसका दें कि सही स्थिति इस बारे में क्या है?

श्री विद्या चरण शुक्ल: मैंने स्वयम् कहा कि जो विदेशी शक्तियों के एजेन्ट हैं वह वहां पर ऐक्टिव हैं भीर उनके द्वारा इस तरह की कार्रवाई की जा रही है।

भी सम् लिसये: प्राप इसका इलाज क्या कर रहे हैं। प्रापने कहा कुछ जानकारी नहीं है।

भी विद्या चरण शुक्लः इलाज क्या करेंगे वह भी बतला चुका हूं।

। परुनाचतला चुनाहू। स्थी मधुलिमयोः नहीं बतलाया है।

मञ्यक्ष[ः] महोदयः वतलाया है। कई सवाल हुए।

Shri Swell: The Deputy Minister. in answer to the question of Shrimati Nigam, stated that the Government has a scheme of settling the border areas with the ex-servicemen of this country. Will he spell out as to which are the areas that Government has decided to settle with ex-servicemen in this country, and whether in coming to any decision in this regard Government have consulted the local border peop'e and got their consent for the operation, or is he going to do all these things over their heads?

Shri Vidya Charan Shukla: We will implement, and we have implemented, this policy with the full consent of the local people. We have tried this as a pilot project in some areas in NEFA to begin with.

Shri Swel: My question has not been answered. This question relates to Assam, not NEFA. He has sald that the Government has agreed to settle ex-servicemen in certain border areas in Assam. My question is that he should mention some of these

areas. He has evaded that part of the question.

Shri Vidya Charan Shukla: The hon, lady Member asked a general question whether we want to settle ex-servicemen in border areas, and so I said this is under our consideration and we have started a pilot scheme.

Shri Swell: He says he has got a scheme . . . (Interruptions.)

श्री ज्ञिष नाराषण: प्रध्यक्ष महोवय,
मैं सरकार से यह जानना चाहता हूं कि जो
पादरी वहां बसे हुए हैं उनमें कितने विदेशी हैं
भीर कितने देशी हैं, भीर जो प्लान्टर्स भयवा
गार्डेनर्स हैं उनमें कितने फारेनर्स हैं भीर
कितने देशी हैं। जो फारेनर्स हैं बाईर पर
उनकी जायदाद के बारे में सरकार क्या सोच
रही है।

श्री विद्या चरण शुक्स: यदि इस बारे में नोटिस दी जाये तो मैं बतला सकता हूं।

Shri Hem Barua: The Assistant High Commissioner's office of Pakistan in Shillong was abolished because of its proved involvement in encouraging Pakistan saboteurs in the State of Assam. In that context may I know whether our Government aware of the fact that the Deputy High Commissioner's office of Pakistan located in Calcutta is actively encouraging Pakistani infiltration into the State of Assam and encouraging rebellion among the hill tribes Assam with arms and ammunitions and, if so, may I know whether the Government considers this as a violation of the Tashkent pact, and if they consider it to be a violation of Tashkent pact by Pakistan, what positive steps are being taken to bring Pakistan into a reasonable frame of mind?

Shri Y. B. Chavan: As far as infiltration is concerned, certainly accept that on their side they are training some people for infiltration. To that extent they have broken the Tashkent spirit.

Shri Hem Barua: And the letter too.

Shri Y. B. Chavan: Both letter and spirit. As far as the political aspect is concerned, we have to think about it. They may have signed the Tashkent agreement insincerely but our approach has been as had been explained on many occasions by the Foreign Minister, we would like to stand by the Tashkent agreement.

Shri Hem Barua: There can be no unilateral implementation of a bilateral pact such as the Tashkent agreement.

Shri Y. B. Chavan: Mr. Hem Barua is entitled to his opinion. I am explaining the Government's position. He may not like it; he may disapprove of it and he is certainly entitled to do so. As far the as the Assam infiltrations are concerned, we are quite aware that they are trying to push in people after training them and we have to take care and see how we resist it. As the Deputy Minister explained, we have taken certain steps and will continue to take certain steps.

Shri Hem Barua: What about the Deputy High Commissioner in Calcutta.

Shri Y. B. Chavan: I would require notice before I make any specific commitment on this question.

Voluntary Retirement

*572. Shrimati Savitri Nigam: Shri D. C. Sharma:

Will the Minister of Home Affairs be pleased to state:

(a) whether Government propose to chalk out a scheme for voluntary retirement in order to raise the standard and efficiency of services and also to get rid of frustrated and disgruntled officers of middle age group; and
