increased their profits during the last few years due to the steep rise in the prices printed on their piece-goods; and

(c) the measures Government propose to take to reduce the prices of these piece-goods to the 1959 level?

The Minister of International Trade in the Ministry of Commerce and Industry (Shri Manubhai Shah): (a) No, Sir.

- (b) Does not arise.
- (c) The several aspects affecting the problem of cotton textiles and prices have been referred to the Tariff Commission for a full enquiry and report under their terms of reference, the Commission will have to recommend inter-alia fair ex-mill prices of cloth and yarn. The matter will be considered further by Government after receiving the Commission's report, which is expected shortly.

Indian Journalists Expelled from East Pakistan

- (c) what facilities our Government are affording to Pakistan newsmen residing in India;
- (d) whether these facilities are on par with the facilities being given to Indian journalists in Pakistan;
- (e) if not, whether attention of the Pakistan Government has been drawn towards this discripancy; and

The Deputy Minister in the Ministry of External Affairs (Shri Dinesh Singh): (a) Yes, Sir, "The Statesman" correspondent Shri Noney and his wife were ordered to leave East Pakistan, at short notice in February,

- (b) On the 10th February, 1962, the passports of Shri W. H. Noney and his wife, which were deposited with the Government of East Pakistan for the renewal of visas, were returned to them with the instructions that they should leave East Pakistan by the 12th February, 1962. Intervention by the Deputy High Commissioner for Andia in Dacca failed to move the East Pakistan Government to reconsider their decision or to allow a reasonable extension of time to enable Shri Noney to wind up his affairs in Dacca.
- (c) and (d). The facilities accorded by the Government of India to an accredited Pakistan newsman in India are the same as those accorded to any other foreign accredited correspondent, except that the Pakistani newsmen have visas valid only for their place of accreditation, which is Delhi in their case, just as Indian correspondents in Pakistan have visas valid for their place of accreditation, which may be Rawalpindi, Karachi or Dacca. This is strictly on the basis of reciprocity.
 - (e) and (f). Do not arise.
