 - Formulation of a coordinated policy for research in Naturecure throughout the country.
 - Steps to be taken for the stimulation of such researcn; and
 - (3) Allocation of Central assistance to institutions carrying on research in nature cure
- (c) The first meeting of the Committee was held on the 9th May, 1962.

Narmada Valley Development Scheme

*817. Shri Birendra Bahadur Singh: Will the Minister of Irrigation and Power be pleased to state:

- (a) whether the note prepared by the Government of Gujerat on the multipurpose development of the Narmada Valley has since been examined by technical experts;
- (b) if so, what is the expert opinion on that; and
- (c) what future action is proposed by the Government of India?
