The Deputy Minister in the Ministry of Transport and Communications (Shri Mohiuddin): (a) and (b). The Indian Airlines Corporation have reported that they have plans to revise, with effect from 1st October, 1962, the pattern of the Night Airmail Services. They envisage that the 4 major cities-Delhi, Bombay, Madras and Calcutta-may have direct services during the night operated with Viscounts, without going through Nagpur. A Skymaster service will continue to operate along the route Bombay Nagpur Calcutta and Calcutta Nagpur Bombay. Nagpur, will, however, have a day connection with Delhi by Dakota service operating on the route Delhi|Gwalior|Bhopal|Nagpur. No final decision has, however, been taken in this regard.
