Officers on Deputation

*452. Shri M. R. Krishna: Will the Minister of Home Affairs be pleased to state:

- (a) whether it is a fact that the Central Government have requested all the State Governments to send their administrative officers to the Centre on deputation;
- (b) how many States have agreed to lend their officers to the Centre and what will be their strength; and
- (c) whether this arrangement will curtail the Central Government's expenditure on administration?

The Minister of State in the Ministry of Home Affairs (Shri Datar): (a) and (b). Under the I.A.S. (Cadre) Rules, framed under the All-India Services Act, 1951, and placed before both the Houses of Parliament, provision has been made in the State cadres for the deputation of officers to the Centre up to the numbers prescribed therein. Due to the expanding activities of the State Governments, however, they have been finding it difficult to spare the officers, as required under these rules. The matter was, therefore, recently taken with the State Governments and they have agreed to do their best to fulfil their obligations in this respect.

(c) The arrangement for deputation of officers from the State Governments to the Centre is an old established one and it does not involve any change in the existing system or any additional expenditure. It has been made to ensure (a) that officers at the Centre have experience of practical administration in the States and in the districts and (b) officers in the States have experience of the administration at the Centre.
