As for contract labour, no broad change is contemplated, except that in respect of goods handling contracts, it is proposed to encourage the award of such contracts to co-operatives of the handling labour.

Licensed porters and contractor's labour, not being railway employees, the question of their enjoying facilitics given to railway servants does not arise. Casual labour directly employed by the railway enjoy facilities appropriate to the nature of their employment
