Ray Saish Chandra: In 1955-56, the imports were Rs. 69,30,00,060 and exports Rs. 87,12,00,000. In 1956-57, the imports ware Rs. 105 crores and exports Rs. 90 crores.

## Employant Provident Fund Act.

"1450. Whit T. B. Vittel Rap: Will the Minister of Labour and Employment be pleased to state;

(a) the reasons for not extending the Employees' Provident Fund Act to the Mica Mines so far:

(b) when it is likely to be enforced; and

(c) the total number of workers employed in these mines as at the end of Janunary, 1958?

The Parliamentary Secretary to the Minister of Labour and Employment and Planning (Shri L. N. Mishra): (a) and (b). As the extension of the Act to the Mica Mines at this stage would be detrimental to the interests of the Industry, it has been decided to keep the matter in abeyance for a year.

(c) The latest information is not available. The number of workers employed in Mica Mines during 1956 was 33,973.

Shri T. B. Vittal Rao: May 1 know when a decision will be taken to extend this Act to the mines?

Shri L. N. Mishra: The matter has been kept in abeyance for a year.

Shri T. B. Vittal Rao: The Planning Commission had stated that the Provident Fund Act should be extended to all the industries during the First Plan period itself. Now we find that even during the Second Plan period it has not been done.

Shri L. N. Mishrs: It is a fact that they recommended that it should be extended. But, in view of the fact that mica is an exportable commodity, the matter was considered by the Export Promotion Council and some other body and it was decided that, for the time being, it should not be extended.
