exports, may I know whether the Government has realised that there will be a big time-lag after the producer goods industries bring out capital goods and further increasing our internal production and exporting them, and can the Government give an idea as to how much of the gap will be filled and how much of the gap will be filled in between the time?

Mr. Speaker: These are all matters of opinion. What is the fact that the hon, Member wants? Next question.

Shrimati Ila Palchoudhuri: May I know how much of this repayment of loan falls due during the next few years on account of the private sector and how much on account of the public sector?

Shri B. R. Bhagat: So far as this particular question is concerned, the statement gives those figures. The private sector is concerned only with regard to deferred payment arrangement and that information is given in the statement.

The Deputy Minister of Finance (Shri B. R. Bharat): (a) Some cases of gold smuggling were detected by the Customs authorities near about Mangalore port in the months of October and November, 1957.

- (b) No such case has been detected at or near about that place during the period of December, 1957 to February, 1958.
 - (c) Does not arise.
- (d) Every possible step is being taken to combat such smuggling. Anti-smuggling measures are being progressively tightened. Wherever possible deterrent action by way of
 - (1) confiscation of goods seized and of vessels, vehicles, or other conveyance used for the removal or concealment of such contraband.
 - (ii) imposition of fines in lieu of confiscation, and
 - (iii) imposition of personal penalties:

through departmental adjudication proceedings together with prosecution in appropriate courts of law, is being taken against such smugglers.

Shri Joachim Alva: In next-door North Kanara, very near South Kanara, the Customs people are rather very hard on women who carry only one pair of bangles. ľ want to know why the Customs are so hard with women crossing into Goa or Karwar territory with one pair of bangles. It is impounded and they have to pay compensation or duty, whatever it is, in the name of checking smuggling. There are lots of complaints of this kind.

Shri B. R. Bhagat: If the hon. Member gives me a synopsis of the complaints that he has received, I will look into them.

Shri Achar: Are there any prosecutions made?

Mr. Speaker: Any prosecutions launched with respect to smuggling?

Shri B. R Bhagat. In this particular case?

Mr. Speaker: Yes, in Mangalore and South Kanara

Shri Achar: In Mangalore, not only within the last few months

Shri B. R. Bhagat: I am unable to give this information in this particular case whether precisely there was prosecution, but generally we have launched a large number of prosecutions

Mr. Speaker. Only with respect to this

Shri B R Bhagat I want notice for this

Shri Achar My information is that prosecutions were made only with regard to some Arabs, but no persons operating in Mangalore were prosecuted If so, what is the reason?

Mr. Speaker. He does not have details The hon. Member will put down a separate question

produced a separate gang of persons, or they have only migrated

R Bhagat: It is very difficult to say, but it is part of the strategy of the smugglers to shift their operations from place to place When they find the Custom's preventive measures are tightening, they change to some other place So, I think they might be operating in South Kanara at a particular period of time

Shri Achar May I know whether any representations were made by certain persons from Mangalore that they were innocent and so on?

Shri B R Bhagat I am not aware of that
