Bridge over River Jia-Bhareli

*1379. Shri P. C. Borooah: Shrimati Mafida Ahmed:

Will the Minister of Transport and Communications be pleased to refer to the reply given to Unstarred Question No. 3563 on the 8th May, 1958 and state:

- (a) whether the sanction for the construction of Jia-Bhareli bridge on the North Trunk Road in Assam has since been given;
- (b) if so, when the construction work will be taken up; and
 - (c) if not, the reasons for delay?

The Minister of State in the Ministry of Transport and Communications (Shfi Raj Bahadur): (a) to (c). A

statement is laid on the Table of the Sabha.

Statement

The construction of the Jia-Bhareli bridge was originally estimated to cost Rs. 60 lakhs and the Government of India had agreed to give a grant-inaid equal to this amount. On the basis of the detailed survey since carried out, the cost of the project is now estimated at Rs. 86:53 lakhs. The question of incidence of the excess exepnditure of Rs. 26:53 lakhs was settled with the Assam Government recently and the Government of India will now bear the cost upto Rs. 77.88 lakhs, the balance being met by the State Government.

2. The estimate for the construction of guide bunds in connection with the bridge is likely to be sanctioned in a few days and the work will be taken up during the current year. The estimate for the bridge itself is under scrutiny and is expected to be sanctioned during the current year.

Failure of Rains in Bikaner Division of Rajasthan
