Smuggling on Rajasthan Border

*557. Shri Ram. Krishan: Will the Minister of Finance be pleased to state:

(a) whether it is a fact that the Rajasthan Armed Constabulary recovered from Partition smugglers

Rs. 61,000, 730 tolas of gold valued at about Rs. 80,000 and a pistol in an encounter with Pakistani smugglers, when they were attempting to cross the border on the night of 2nd May, 1958 in Sri Ganganagar area; and

(b) if so, whether any smuggler was killed, injured or arrested?

The Deputy Minister of Finance (Shri B. R. Bhagat): (a) Yes, Sir. It is a fact that the Rajasthan Armed Constabulary recovered the following goods from three smugglers (of whom one was Pakistani and the other two were Indians) while attempting to cross the border on the night of 2nd/3rd May, 1958 near village 63 F on the Indo-Pakistan border; fire was exchanged from both sides.

730 tolas of gold

1 Pistol (32 bore with 5 cartridges)

3 wrist watches and one pen.

Total value—Rs. 80,900 and
Rs 73-12-0 (Pak currency).

On the same night 250 tolas of gold were also recovered from a Pakistani national by the Rajasthan Armed Constabulary, Govindgarh. No encounter took place.

(b) No person on either side was killed or injured. All the smugglers mentioned above were arrested.

Birth Centenary of Rabindranath Tagore

The Minister of Scientific Research and Cultural Affairs (Shri Humayun Kabir): The following is the progress 288 r

made by the Sahitya Akademi in regard to the publication of works of Shri Rabindranath Tagore on the occasion of his birth centenary celebrations:---

- 1. The devanagari edition of 101 select poems of Rabindranath Tagore (original Bengali text, fully annotated) has been printed and is expected to be brought out shortly under the title, "Ekottarasati".
- 2. The manuscripts of the devanagari editions of 500 songs and 21 short stories are completed and arrangements are being made for their printing.
- 3. Manuscripts of the transliterated editions of six Dramas. and two Novels are under preparation.
- 4. The selection of material for the remaining three volumes concerning essays, travelogue, letters, etc is being made
- 5. Some of the above volumes are under translation in many Indian languages. The Gujarati edition of 21 short Stories has been published The manuscript of the Punjabi edition is ready for press Other assignments for translation will be made after the Devanagari editions are ready
- 6. It has also been decided publish a two-volume selection of Tagore's writings in Nepali and Tibetan.
