The Andhra Pradesh Sangeet Natak Akademi proposed the setting up of a School of Kuchipudi Natya in Kuchipudi Village and an Institute for advanced courses in Vijayawada. The Sangeet Natak Akademi has given an ad hoc non-recurring grant of Rs. 3,600 during 1959-60 to the Andhra Pradesh Akademi to meet part of the expenditure on the school in Kuchipudi.

Loan to Orissa

(a) the total amount of Central loan which is due from Orissa as on the 31st March, 1960;

(a) the total amount of interest which is due from Orissa till the 31st March, 1960 on Central loans advanced to Orissa;

(c) the various heads under which the Central loans have been advanced to Orissa; and

(d) whether Orissa has made any payment towards the loan capital?

The Minister of Finance (Shri Morarji Desai): (a), (b) and (d). As the accounts for the year 1959-60 are still open, it is not possible at this

stage to give the information asked for by the honourable member relating to that year. A sum of Rs. 123.33 crores was, however, outstanding against Orissa as loans on 31st March, 1959 and a sum of Rs. 3.67 crores was recovered as interest during the year 1958-59. The Orissa Government also repaid loans amounting to Rs. 4.5 crores during that year.

(c) The loans are for numerous purposes, the important items of which are Hirakud Dam Project, Grow More Food Schemes, States' share of small savings collections, Community Development Projects and Local Development Works, Industrial and Housing Schemes, Development of Khadi and Handloom, etc.
