The first impact of T.V. on viewers and Tele-clubs formed under the project, has been examined in a general way but it is too early to come to conclusions. The formulation of a suitable scheme for an assessment of the impact of Television as a means of education and culture is in hand. The utilisation of T.V. as a means of entertainment is not being emphasised in the present scheme.

- (b) if so, the main features of the trade pact; and
- (c) the steps taken to export Indian products to Yugoslavia?

The Deputy Minister of Commerce and Industry (Shri Satish Chandra): (a) Yes, Sir.

- (b) The main features of the agreement are:
 - (i) The exchange of goods between India and Yugoslavia will as far as possible be on the basis of balanced trade.
 - (ii) All payments between two countries will be effected in non-convertible rupees.
 - (iii) After the expiry of the agreement, the credit balance appearing in the Central Clearing Accounts of Yugoslavia with the Reserve Bank of India will have to be liquidated by delivery of Indian goods or in such manner as may be agreed upon between the two parties.
- (c) The conclusion of the fresh trade agreement is itself a concrete step to promote the development of balanced trade between the two countries on a higher level.
