- (b) if so, the reasons therefor; and
- (c) whether any action has been taken by Government to check the rise in prices?

The Deputy Minister of Agriculture (Shri M. V. Krishnappa): (a) There has been a rise in the prices of groundnuts, groundnut oil and cakes in recent weeks.

- (b) The rise in prices of groundnuts, groundnut oil and cakes has been due to increase in internal demand, reports of damage to the crop in 1959-60 season, coupled with the speculative activities of the trade caused by the expectation of a lower crop.
- (c) Steps have been taken and continue to be taken to increase the production of groundnut and thereby augment the production of groundnut oil and cakes. Exports of groundnut, groundnut oil and cake are also regulated to check any abnormal rise in their prices. Measures to curb speculative activity have also been taken by the Reserve Bank and by the Forward Markets Commission.

A scheme for coment concreting about 147 miles of existing sections of National Highways, involving an estimated expenditure of about Rs. 4:63 crores, has been approved. Schemes are being formulated for the utilisation of the balance of Rs. 2:36 crores on cement concreting some more sections of National Highways.

### Western Shipping Corporation

### The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) Yes.

(b) Both the seamen were drunk and were quarrelling with each other. As a result one pushed the other overboard but having lost balance he himself also fell from the launch. Rescue operations were not successful as it was midnight and the visibility was poor.

The police have registered a case and the Shipping Master, Bombay has held an enquiry into this accident.
