**Stoppage of Doles to Displaced Persons in Bettiah**

\*1203. **Shri Subiman Ghose:** Will the Minister of Rehabilitation and Minority Affairs be pleased to state:

(a) whether cash doles to 500 or more displaced persons at Bettiah, Bihar, have been stopped or will be stopped from March, 1960;

(b) if so, the reasons therefor; and

(c) what steps Government has taken for their rehabilitation?

**The Deputy Minister of Rehabilitation (Shri P. S. Naskar):** (a) No.

(b) Does not arise.

(c) Efforts are being made to rehabilitate most of the displaced persons in the Bettiah Camp in Bihar. Those persons who cannot be settled within the State will be given the option for work/rehabilitation in Dandakaranya. If they are not willing to go to Dandakaranya, they will be paid cash grant equivalent to six months' dole. It has been decided to close the Bettiah Camp by the end of June, 1960.
